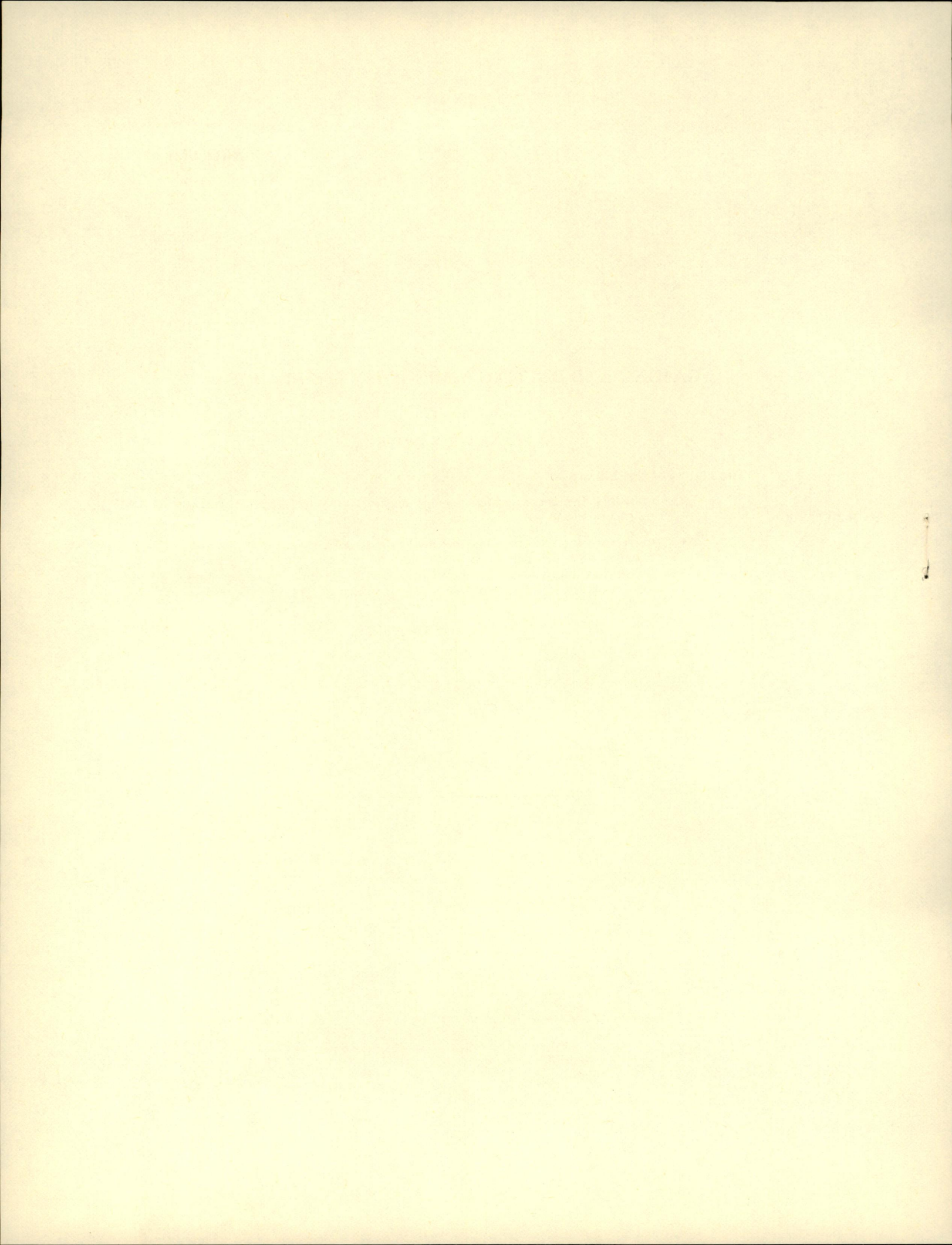

GAMING AND BETTING (AMENDMENT) BILL, 1975

EXPLANATORY NOTE

THE objects of this Bill are—

- (a) to reduce the age at which persons may bet or wager from 21 years to 18 years; and
 - (b) to remove a restriction on the publication, before an event or contingency on which bets have been made through the Totalizator Agency Board has taken place or been decided, of information concerning totalizator dividends or probable totalizator dividends payable in respect of those bets.
