A BILL

To provide for the appropriation of a certain sum out of the General Loan Account and for the application of that sum for certain Public Works and Services; and for purposes connected therewith.

WHEREAS

General Loan Account Appropriation.

WHEREAS the Australian Loan Council at its one-hundred and third meeting held on the twenty-eighth day of June, one thousand nine hundred and seventy-three, decided in pursuance of Clause 3 (9) of Part I of the Agreement set out in the schedule to the Financial Agreement Act, 1944, that the amount to be borrowed for the loan programmes of the Commonwealth and the States for State works for the financial year ending on the thirtieth day of June, one thousand nine hundred and seventy-four, shall be eight hundred and sixty-seven million dollars, and by unanimous decision allocated an amount of two hundred and sixty-nine million six hundred and twenty-nine thousand dollars to the State of New South Wales, BE it enacted therefore by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same as follows:—

1. This Act may be cited as the "General Loan Account Short title, Appropriation Act, 1973".

2. The sum of three hundred and seventy-eight million eight hundred and fifty-six thousand dollars is hereby appropriated from the General Loan Account for the public works and services hereunder set out, and shall, as required, be applied as follows:—
