**EXPLANATORY NOTE**

1. Clause 1 specifies the short title of the proposed Act.
2. Clause 2 amends the Principal Act and—
  - (a) by clause 2 (a)—
    - (i) defines “unimproved capital value”, in relation to colliery holdings, by reference to the Local Government Act, 1919, or, in the absence of a valuation under that Act, by reference to the Valuation of Land Act, 1916, instead of by reference to either of those Acts, to avoid the contributions of proprietors of those holdings to the Mine Subsidence Compensation Fund being based on conflicting valuations;
    - (ii) provides that contributions shall be based on the first unimproved capital value of a colliery holding that comes into force where no such valuation of that holding is in force on 30th June in the year in respect of which the contribution is payable;
    - (iii) provides that, instead of the contributions in respect of any year being payable on the expiration of the period of 28 days after the service of a notice thereof, they shall be payable—
      - (a) on the expiration of that period or on 28th January in the following year, whichever is the later; or
      - (b) if a further notice is served in the place of an incorrect notice, on the expiration of the period of 28 days after the service of that further notice;
    - (iv) provides for the apportionment of contributions where there is a change in the proprietorship of a colliery holding;
    - (v) deems unpaid contributions to the Mine Subsidence Compensation Fund to be debts due to the Crown; and
    - (vi) empowers the Mine Subsidence Board to exempt the proprietor of a colliery holding from paying his contribution for that part of the year during which mining operations had not commenced;

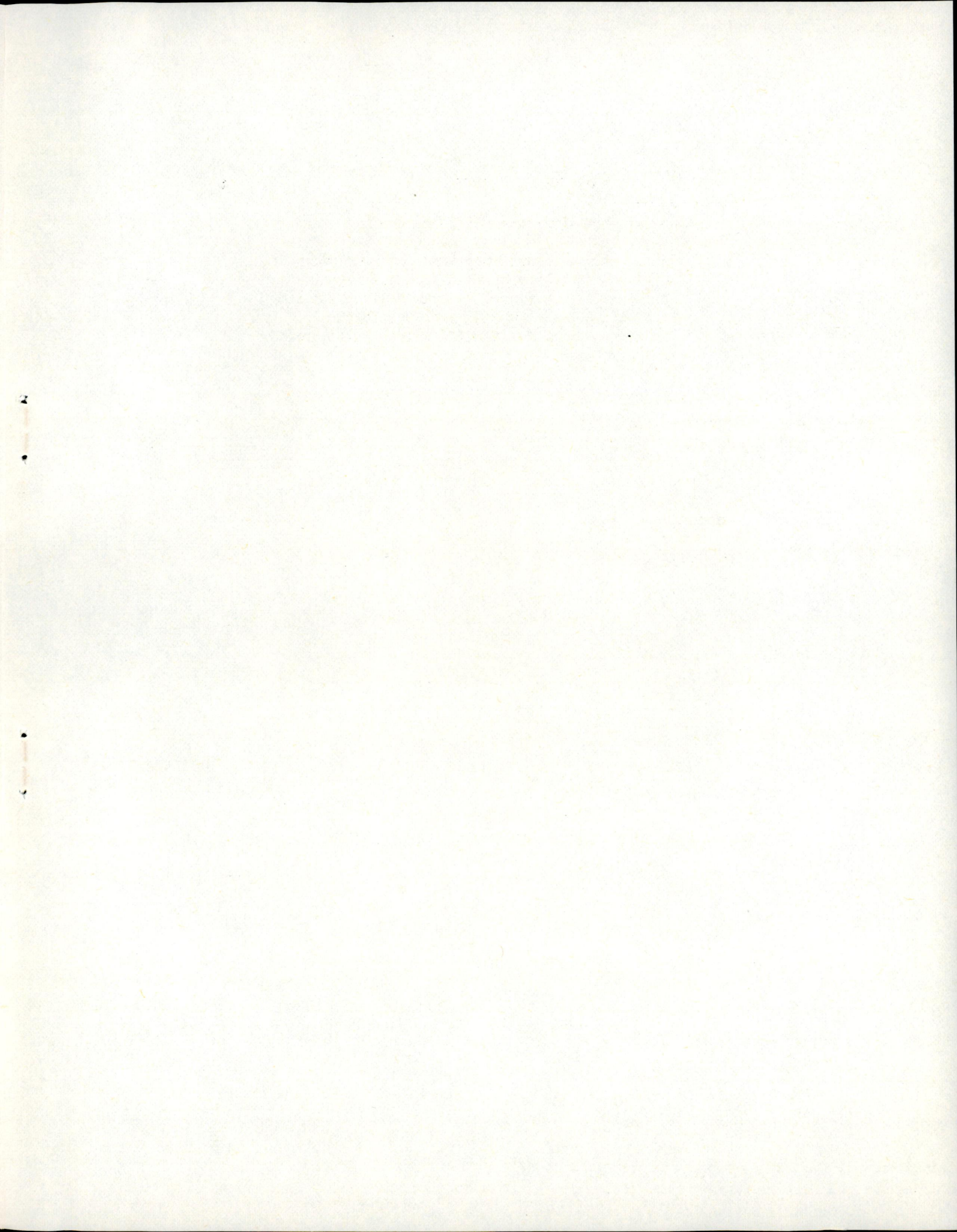

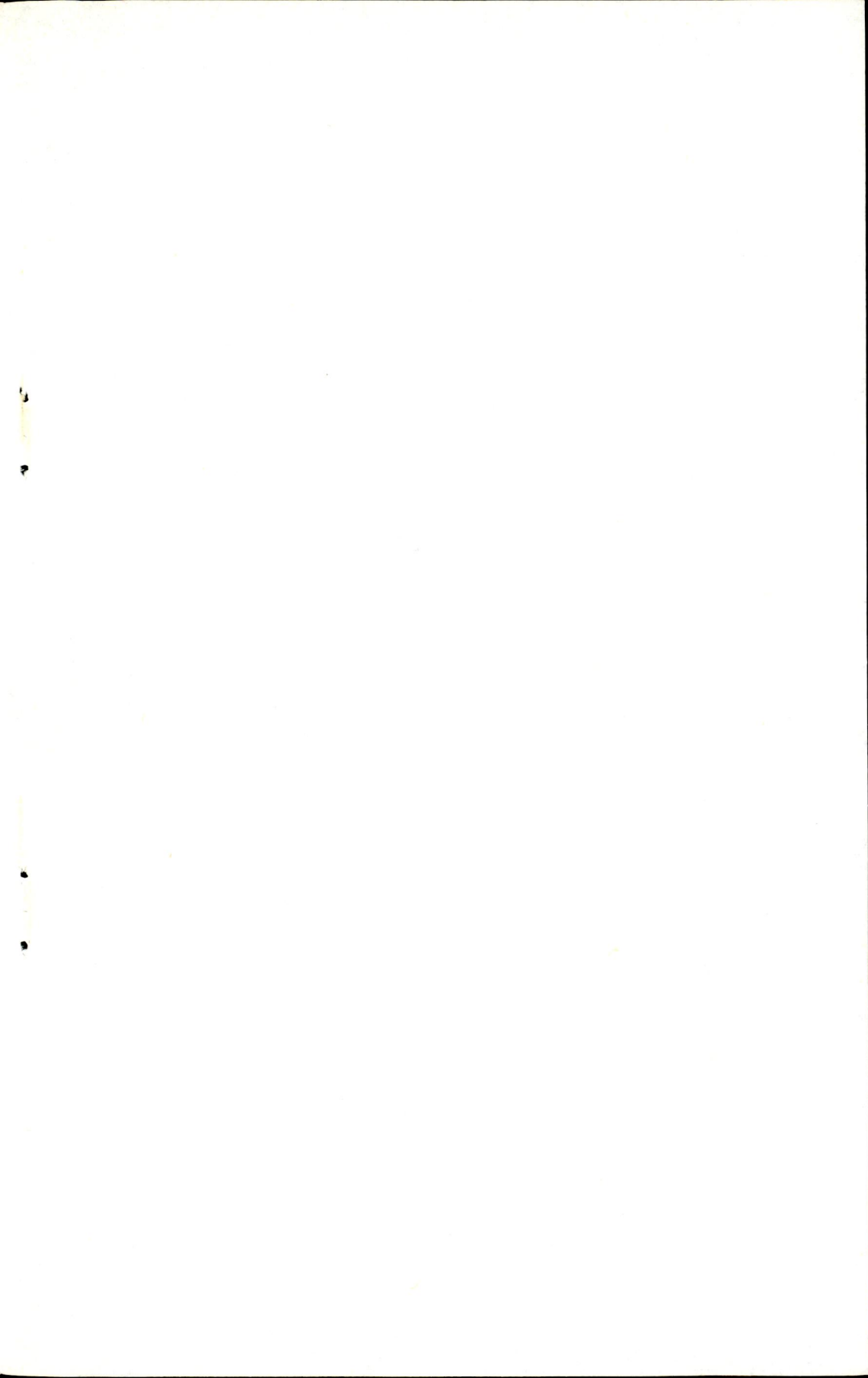

(1A) Subject to this section, the proprietor of each colliery holding shall in respect of each year contribute to the Fund a sum calculated in such manner as may be prescribed.

(i) on the unimproved capital value of that colliery holding as in force on the thirtieth day of June in that year;

(4) Interest, at such rate, not exceeding 10 per centum per annum, as may be determined by the Board from time to time for the purposes of this subsection, shall be paid by the proprietor of a colliery holding on the amount of his contribution that has not been paid on the date it becomes due and payable in respect of the period from that date until the date of payment of that amount.

Validation. **3.** Any act, matter or thing done or commenced or omitted to be done before the commencement of this Act which would, if that act, matter or thing were done or commenced or omitted to be done after that commencement, be authorised by this Act, shall be valid and shall have the same force and effect as if that act, matter or thing were done or commenced or omitted to be done under this Act after that commencement.
