Act No. , 1976.

An Act to amend the Mining Act, 1973, so as to make further provision in relation to the disposal of certain applications under that Act, to provide for the conduct of tourist activities in mining areas and mining purposes areas, and in certain other respects; and to validate certain matters.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

- 1. This Act may be cited as the "Mining (Amendment) Short Act, 1976".
- 2. (1) This section and sections 1, 3 and 6 shall Commence-commence on the date of assent to this Act.

EXPLANATORY NOTE

THE objects of this Bill are-

- (a) to provide that where a copy of a notice published in a newspaper is to be lodged for the purposes of the Mining Act, 1973, so much of the newspaper as contains the name and date of the newspaper is also to be lodged (Schedule 1 (2) (a));
- (b) to establish that where a notice is published in a newspaper it is deemed to be published on the date of the newspaper (Schedule 1 (2) (b));
- (c) to provide that a document authorised or required to be served on a person that is served by post need not be served by certified mail if it is served by the Minister, the warden, a mining registrar or another officer referred to in section 14 (1) of the Mining Act, 1973 (Schedule 1 (3));
- (d) to remove the requirement that the Minister approve of the form of an application to a court (Schedule 1 (4) (c));
- (e) to enable two classes of fossicking licences, namely personal fossicking licences and family fossicking licences, to be issued and to make further provision in relation to fossicking licences (Schedule 2 (1));

I have examined this Bill, and find it to correspond in all respects with the Bill as finally passed by both Houses.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—
