An Act to revise references in certain Acts to Ministers of the Crown and Government Departments; and for this and other purposes to amend various Acts.

**BE**

*Miscellaneous Acts (Administrative Changes) Amendment.*

**B**E it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

1. This Act may be cited as the "Miscellaneous Acts Short title. (Administrative Changes) Amendment Act, 1976".

2. In this Act or in an instrument made for the purpose of this Act, a reference to an Item or Item number, however expressed, is a reference to a number, in the column headed "Item No." in Column 1 of Schedule 1 and the provisions of Schedule 1 set forth opposite that number.

3. (1) This section and sections 1, 2 and 5 shall commence on the date of assent to this Act.

15 (2) Section 4 shall, in its application to an Item of Schedule 1, be deemed to have commenced on the day on which that Item is deemed to have commenced.

(3) Items 1-13 of Schedule 1 shall be deemed to have commenced on 3rd January, 1975.

20 (4) Item 14 of Schedule 1 shall be deemed to have commenced on 24th October, 1973.

(5) Item 15 of Schedule 1 shall be deemed to have commenced on 18th December, 1974.

25 (6) Item 16 of Schedule 1 shall be deemed to have commenced on 30th January, 1976.

4. Each Act specified in Column 1 of Schedule 1 is amended in the manner set forth opposite that Act in Column 2 of Schedule 1.

5. A regulation or rule made under any Act amended by this Act for the purpose of replacing a reference to a Minister of the Crown, Government Department or office in a Government Department with a reference to some other Minister of the Crown, Government Department or office in a Government Department may be made so as to take effect on and from 3rd January, 1975, notwithstanding that it is made or published in the Gazette after that date, provided it is made and published in the Gazette before 1st January, 1977.

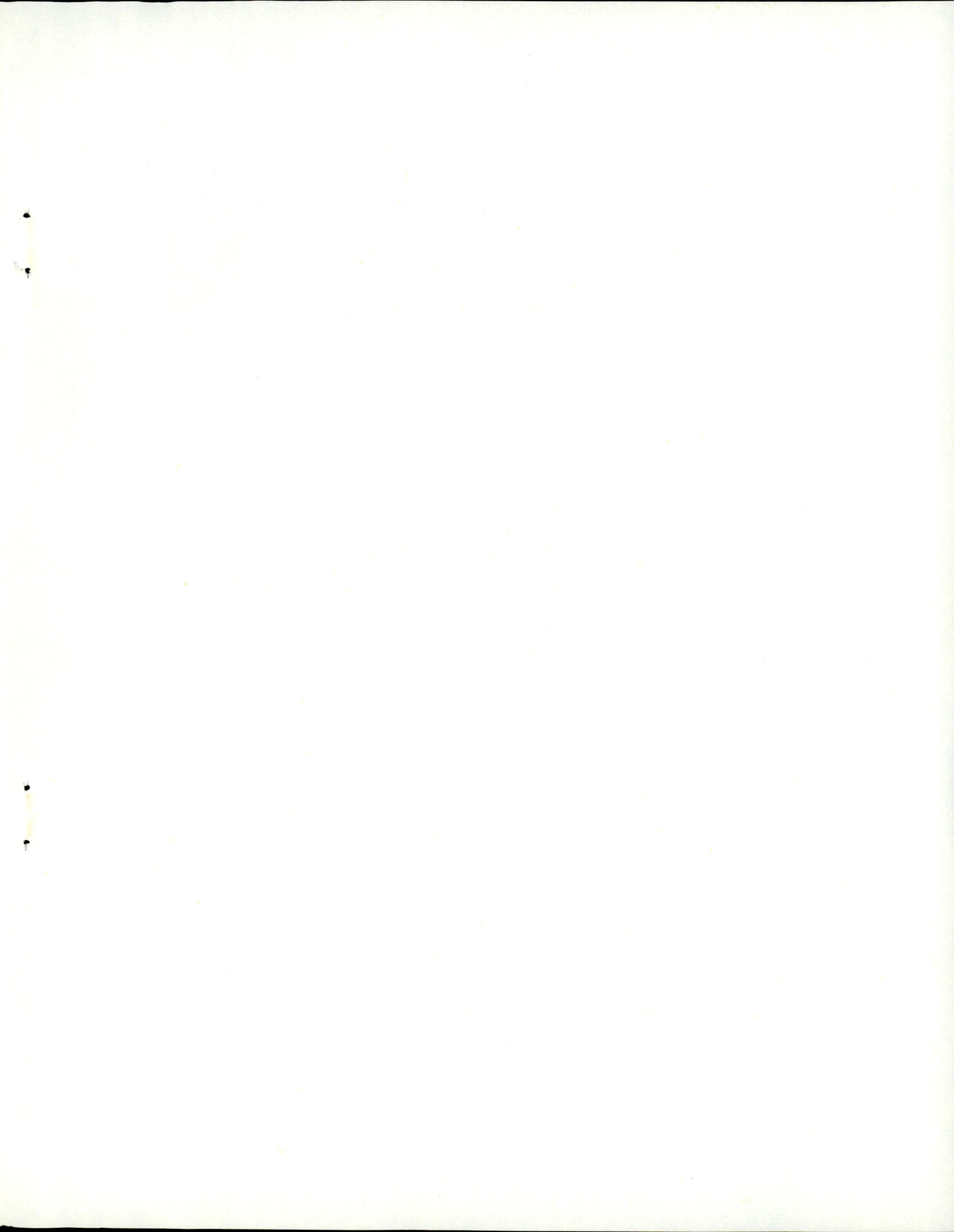

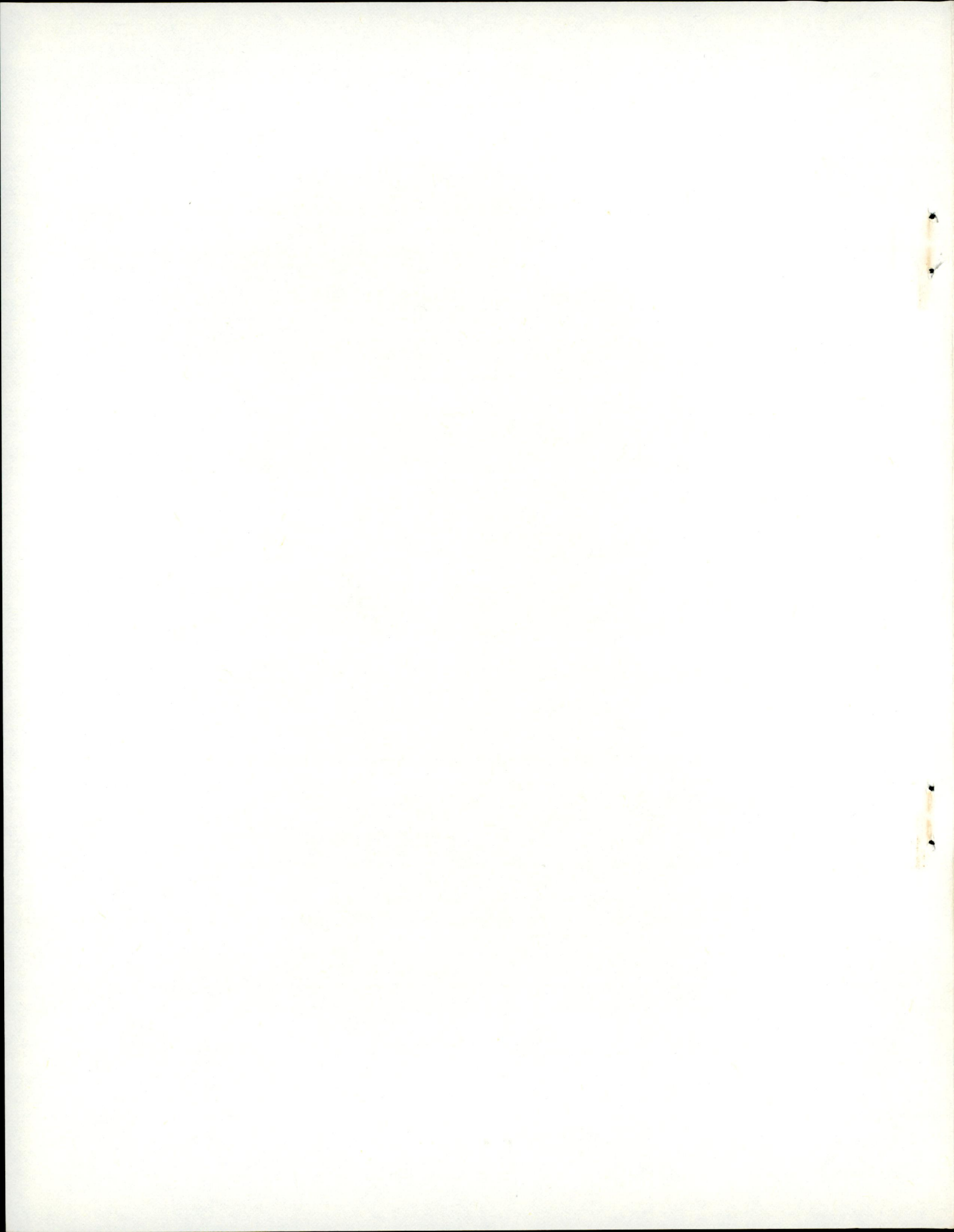

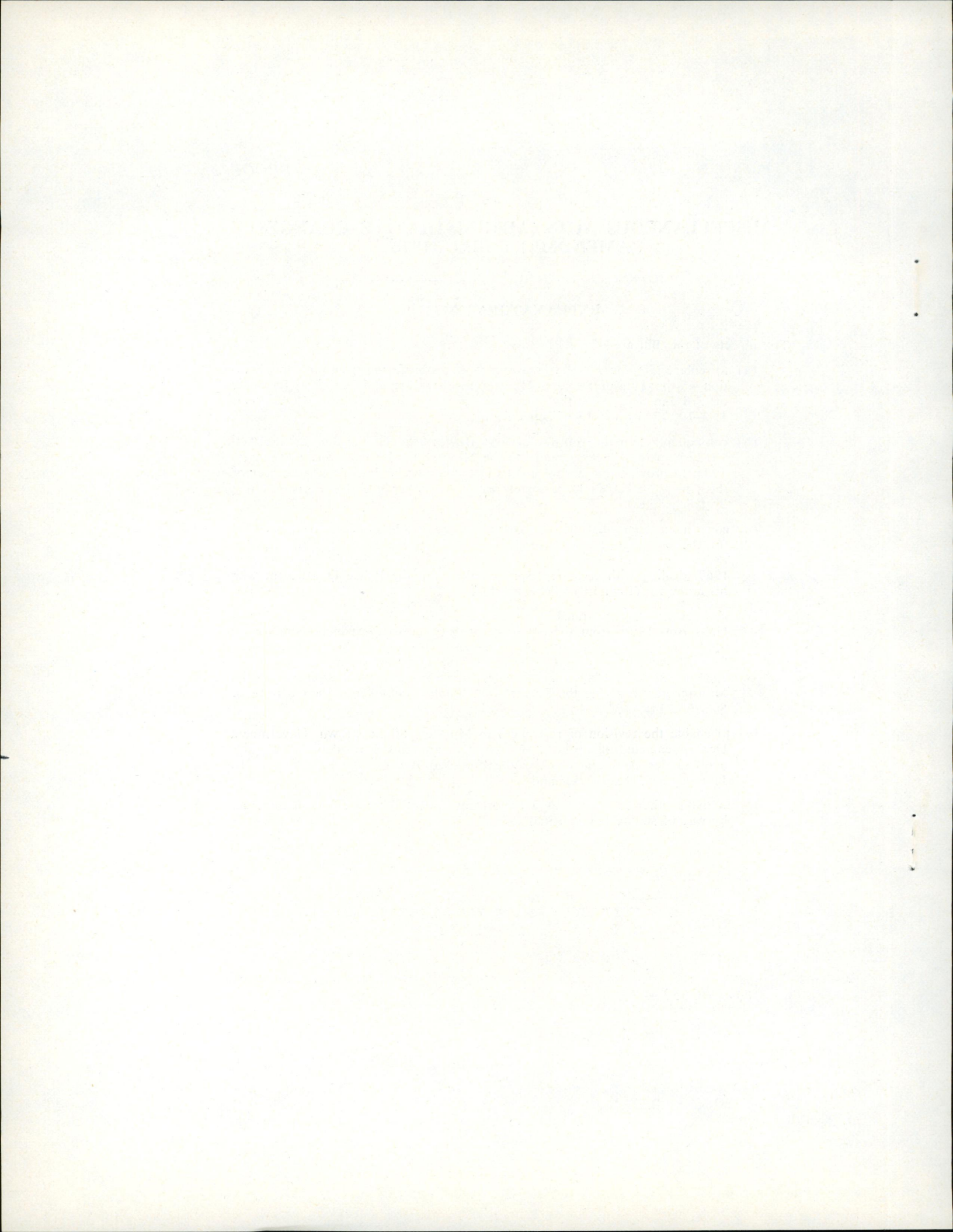

**EXPLANATORY NOTE**

THE objects of this Bill are—

- (a) to replace references to the Treasurer in Acts transferred from the administration of the Treasurer to the Minister for Revenue and Assistant Treasurer on 3rd January, 1975, that are no longer appropriate (clause 4 and Items 1, 3-10, 12, 13 and 15 of Schedule 1);
  - (b) consequent upon the transfer of Part IIIA of the Gaming and Betting Act, 1912, from the Chief Secretary to the Minister for Revenue on 3rd January, 1975, to provide that an officer of the Public Service instead of an officer of the Chief Secretary's Department may issue poker machine licences (Item 2 of Schedule 1);
  - (c) consequent upon the Premier ceasing to have administrative responsibility for the police force on 24th October, 1973, to revise a reference to the Premier in a provision of the Transport Employees Retirement Benefits Act, 1967, dealing with certain persons employed in the Police Department with his authority (Item 14 of Schedule 1);
  - (d) consequent upon the transfer of the administration of the Theatres and Public Halls Act, 1908, from the Minister for Services to the Chief Secretary on 23rd January, 1976, to replace a reference in the New South Wales Film Council Act, 1974, to the Minister for Services nominating a person for appointment to the New South Wales Film Council with a reference to the Minister administering the Theatres and Public Halls Act, 1908 (Item 16 of Schedule 1);
  - (e) to enable the revision of references to Ministers of the Crown, Government Departments and offices in Government Departments in regulations and rules made under Acts amended by the proposed Act to take effect from 3rd January, 1975 (clause 5); and
  - (f) to make other provisions of a minor, consequential or ancillary nature and by way of statute law revision.
