

An Act to amend the Pastures Protection Act, 1934, in relation to noxious animals, travelling stock, pastures protection boards, penalties for offences and other matters dealt with in that Act; and to validate certain matters.

B^E it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:-

1. This Act may be cited as the "Pastures Protection Short title. (Amendment) Act, 1976".

2. (1) This section and sections 1, 3 and 5 shall Commencecommence on the date of assent to this Act.

10 (2) Section 4 shall, in its application to a provision of Schedule 1, 2 or 3, commence or be deemed to have commenced on the day on which that provision commences or is deemed to have commenced, as the case may require.

(3) Subject to subsection (4), the several provisions15 of Schedules 1, 2 and 3 shall commence on such day or days as may be appointed by the Governor in respect thereof and as may be notified by proclamation published in the Gazette.







EXPLANATORY NOTE

THE objects of this Bill are-

- (a) to provide that, subject to the Principal Act and the regulations, a pastures protection board may determine the procedure for the conduct of its meetings (Schedule 1 (2));
- (b) to empower the Governor to remove a pastures protection board from office if the board, after notice from the Minister, does any act not authorised by the Principal Act or any other Act (Schedule 1 (3));
- (c) to provide for the payment to directors of pastures protection boards of such fees and expenses as the Minister determines instead of only prescribed travelling and hotel expenses (Schedule 1 (4));
- (d) to authorise a pastures protection board to purchase and sell certain articles to an occupier of land in its district at cost (Schedule 1 (5));
- (e) to authorise the imposition of terms and conditions on the application of moneys from a pastures protection fund or reserves improvement fund to a purpose approved by the Minister or prescribed by the regulations (Schedule 1 (6) and (13));
- (f) to empower special permit officers appointed by a pastures protection board to issue permits, on forms supplied by the board and charged with the prescribed permit fee, for certain stock to travel by motor transport (Schedule 1 (7), (12) (f), (14) (a) and (15));
- (g) to extend the power of a pastures protection board to grant a rebate of rates to occupiers of groups of holdings not enclosed by a rabbit-proof fence where the occupiers take co-operative action to keep their holdings reasonably free from rabbits (Schedule 1 (8));
- (h) to enable proceedings to be taken within 12 months instead of 6 months against persons who fail to notify a pastures protection board of changes in the occupancy of ratable land (Schedule 1 (9));
