



#### EXPLANATORY NOTE

THE Public Works (Amendment) Act, 1975, clarified the situation with respect to the rates of interest payable on compensation for compulsory acquisitions of land that took effect before the commencement of that Act (18th December, 1975). The objects of this Bill are—
