






## STRATA TITLES (AMENDMENT) BILL, 1976

#### **EXPLANATORY NOTE**

THE objects of this Bill are-

- (a) to extend, from seven to fourteen days after its constitution, the time within which a body corporate under a strata scheme is required to determine the amount of levies to be made on proprietors (Schedule 1 (2) (a));
- (b) to require moneys received by a body corporate under a strata scheme by way of discharge of insurance claims to be deposited in its sinking fund (Schedule 1 (2) (b));
- (c) to require the body corporate under a strata scheme to deposit in a bank uninvested moneys forming part of the administrative fund or the sinking fund (Schedule 1 (2) (c));
- (d) to facilitate the recovery by a body corporate under a strata scheme of property of the body corporate entrusted to persons in connection with the administration of the strata scheme (Schedule 1 (4));
- (e) to enable the disponee of a strata lot to give to the body corporate notice
  of the transfer to him of the lot so as to enable his name to be recorded
  in the strata roll where the disponor has failed to give a notice (Schedule
  1 (5) (a));
- (f) to reduce the information required to be given to the body corporate by a proprietor who leases his lot (Schedule 1 (5) (b));
- (g) to ensure that Strata Titles Boards are not restricted in varying unit entitlements where existing entitlements are low in number (Schedule 1 (6), (7));
- (h) to facilitate the service on a body corporate of notices and orders under Part V of the Strata Titles Act, 1973 (Schedule 1 (8));
- (i) to require the secretary of each body corporate to call nominations for election to the council of the body corporate (Schedule 1 (9));
- (j) to extend the period during which an original proprietor may be required to carry out the duties of the chairman, secretary and treasurer (Schedule 1 (10)); and
- (k) to make other provisions of an ancillary, consequential or minor nature.



- (b) the strata roll kept by a body corporate; or
- (c) any other property of a body corporate,

shall, within seven days after service on him of notice of a resolution of the council requiring him to do so, deliver those records, books of account and keys and that strata roll and other property to a member of the council specified in the notice.

Penalty for an offence against this subsection: \$500.

(7) Subsection (6) does not apply in respect of a person who has possession or control of any of the property referred to in subsection (6) (a), (b) or (c) if that person is the managing agent of the body corporate concerned and is the holder of a real estate agent's licence issued pursuant to the Auctioneers and Agents Act, 1941.

#### (5) (a) Section 81 (2A)—

#### After section 81 (2), insert :—

(2A) Where the disponor under an executed transfer of a lot does not comply with a notice under subsection (10) requiring him to give a notice under subsection (2) in the capacity of the disponor under the transfer, the disponee under the transfer may give to the body corporate written notice of the transfer which shall identify the lot and specify the name of the disponee in full and the address for the service of notices on the disponee and the date upon which the transfer was delivered to the disponee.
