BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title. 1. This Act may be cited as the "Bread (Amendment) Act, 1977".

Amendment of Act No. 54, 1969. 2. The Bread Act, 1969, is amended by inserting after section 13 (4) the following subsection:—

(4A) Subject to this Part, but notwithstanding subsection (4), where—

- (a) the date of issue of a certificate is after 31st December, 1977, the certificate shall remain in force until cancelled; and
- (b) the date on which the renewal of a certificate takes effect is after 31st December, 1977, the renewal shall remain in force until cancelled.
