EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

THE objects of this Bill are-

- (a) to require a fund, which shall be known as the "Builders Licensing Board Special Insurance Fund" (hereinafter referred to as the "Special Insurance Fund") to be created in the books of the Builders Licensing Board (Schedule 1 (1));
- (b) to provide that the Special Insurance Fund shall consist of a prescribed proportion of fees paid in connection with restricted licences under the Builders Licensing Act, 1971 (Schedule 1 (4));
- (c) to validate certain acts or omissions done or made in contemplation of the creation of the Special Insurance Fund (clause 4); and
- (d) to make other provisions of a minor, a consequential or an ancillary nature.
