**B**<sup>E</sup> it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

## Short title.

**1.** This Act may be cited as the "Bush Fires (Amendment) Act, 1976".

Commencement. 2. (1) This section and sections 1 and 3 shall commence on the date of assent to this Act.
