**DEPARTMENT OF AGRICULTURE (REPEAL) BILL, 1976**

**EXPLANATORY NOTE**

THE object of this Bill is to repeal the Department of Agriculture Act, 1907. That Act provides for the creation of the office of Minister of Agriculture and the establishment of the Department of Agriculture.

The Bill contains the following provisions :—

Clause 1. Short title.

Clause 2. Commencement.

Clause 3 repeals the Department of Agriculture Act, 1907.

Clause 4 provides for the continuance, subject to clause 5, of the Department of Agriculture.

Clause 5 provides that nothing in the proposed Act affects any power to create, establish, abolish or change the title of any Ministerial office or Department.
