FARMERS' RELIEF (AMENDMENT) BILL, 1977

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

THE object of this Bill is to extend the operation of section 40D of the Farmers' Relief Act, 1932, to the Agreement within the meaning of the Dairy Adjustment Programme Agreement Ratification Bill, 1977, and to the Agreement within the meaning of the States Grants (Rural Adjustment) Agreement Ratification Bill, 1977.

Section 40D requires money received by the State under various agreements to be made available to the Rural Bank for the purposes of the Rural Reconstruction Agency.
