EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

THE objects of this Bill are-

- (a) to provide for the automatic annual adjustment of superannuation allowances and pensions payable under Part IX of the Government Railways Act, 1912, by reference to the percentage increase or decrease in the Consumer Price Index (All Groups Index) for Sydney during the year 1975-6 and in each subsequent year, unless the percentage is less than 1% (Schedule 1 (4), (11) and (12));
- (b) to insert into the Government Railways Act, 1912, a new section 129F, which limits the amount by which a superannuation allowance or pension may be reduced by the above provisions, so that the allowance or pension is not reduced below the amount at which it emerged (Schedule 1 (12));
- (c) to provide an alternative method of determining the amount payable for a newly emerging superannuation allowance, so as to avoid discrepancies between the amount of such an allowance and the amount of an allowance that has been automatically adjusted (Schedule 1 (3) (b) and (7));
- (d) to provide for the automatic annual adjustment of the maximum rate of salary deductions (Schedule 1 (5));
- (e) to revise section 115 (1) of the Government Railways Act, 1912, so that the provisions for abatement of a superannuation allowance by reference to contribution levels accord with the increases of contributions rates since 6th January, 1952 (Schedule 1 (8) (a));
