Liquor (Amendment).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title. **1.** This Act may be cited as the "Liquor (Amendment) Act, 1976".

Amendment of Act No. 42, 1912. **2.** The Liquor Act, 1912, is amended in the manner set forth in Schedule 1.

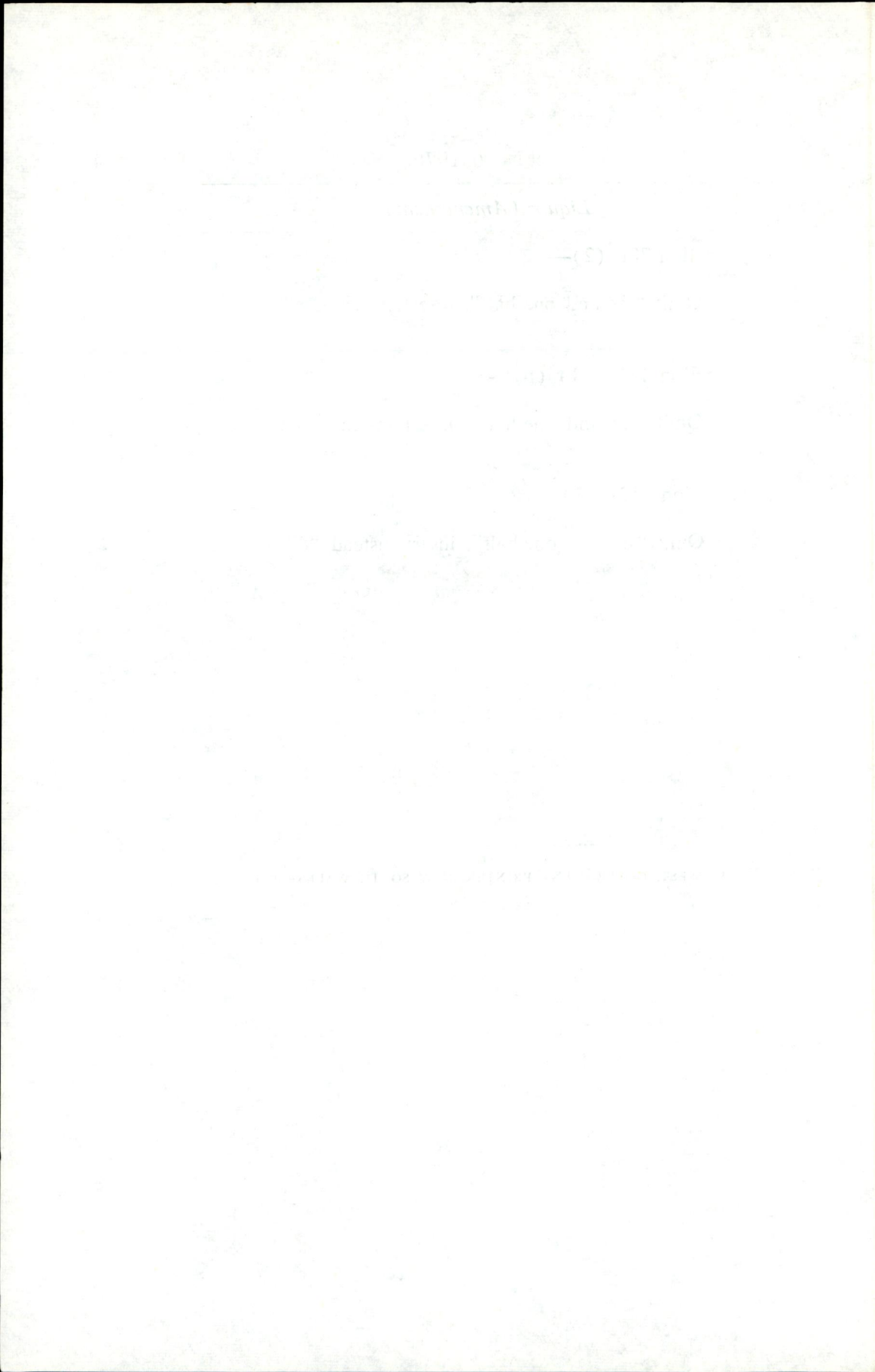
