## **MEAT INDUSTRY (AMENDMENT) BILL, 1977**

---

### **EXPLANATORY NOTE**

THE object of this Bill is to authorise the Metropolitan Meat Industry Board to trade in animals and meat.

The Bill amends the Meat Industry Act, 1915—

- (a) to authorise the board to take delivery of animals and to slaughter them on its own behalf, as well as on behalf of other persons (Schedule 1 (1) (a));
  - (b) to authorise the board to purchase animals or meat (Schedule 1 (1) (b));
  - (c) to authorise the board to sell animals or meat on its own behalf, as well as on behalf of other persons (Schedule 1 (1) (c));
  - (d) to authorise the board to export meat on its own behalf, as well as on behalf of other persons (Schedule 1 (1) (d));
  - (e) to authorise the board to apply a manufacturing process to meat as well as to offal and other matter (Schedule 1 (1) (e) and (f));
  - (f) to extend the definition of "meat" for the purposes of section 7 (1) of that Act so that the board's power to trade in meat extends to meat products such as are used for human consumption (Schedule 1 (1) (g)); and
  - (g) to authorise the board to make by-laws providing for the application of any manufacturing process to meat as well as to offal and other matter (Schedule 1 (2)).

## MEAT INDUSTRY (AMENDMENT) BILL 1977

### EXPLANATORY NOTE

The object of this Bill is to amend the Meat Industry (Marketing) Board in terms of section 1 of the Meat Industry (Marketing) Act 1968.

The Board is to be renamed the Meat Industry Board.

The Board is to be empowered to do such things as may be necessary or expedient for the purposes of the Act, and to exercise the powers conferred on it by or under the Act.

The Board is to be a body corporate with perpetual succession.

The Board is to be composed of such persons as may be appointed by the Minister, and the Minister may remove any person appointed to the Board.

The Board is to have the power to borrow money, and to invest any moneys which may be received by it.

The Board is to be liable to be sued, and to sue, in its own name.

The Board is to be subject to the provisions of the Companies Act 1965, in so far as they apply to companies limited by guarantee.
