B^E it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title. 1. This Act may be cited as the "Public Works and Other Acts (Interest Rates) Amendment Act, 1976".

Commencement. 2. This Act shall be deemed to have commenced on 18th December, 1975.
