## SOCCER FOOTBALL POOLS (AMENDMENT) BILL, 1976

---

### EXPLANATORY NOTE

THE objects of this Bill are—

- (a) to alter the name of the Fund established under section 17 of the Soccer Football Pools Act, 1975, from Sports and Recreation Fund to Sport and Recreation Fund;
- (b) to repeal the provision of that Act that limits the amount of the duty and additional duty payable to that Fund to half the amount of duty and additional duty received by the Minister, with a maximum amount of \$3 million in any financial year; and
- (c) to include in that Act a provision that requires the payment to that Fund of two-thirds of the amount of the duty and additional duty received by the Minister.

The amendments are to take effect from 1st January, 1977.
