An Act to constitute the Sydney Cricket and Sports Ground Trust; to provide for the dedication of certain lands for public recreation; to appoint the Trust as trustee of those lands and to charge the Trust with the care, control and management thereof; to confer and impose on the Trust certain responsibilities, powers, authorities, duties and functions in relation to those and other lands;

and

and to repeal the Sydney Sports Ground and Sydney Cricket Ground Amalgamation Act, 1951, and certain other enactments.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

20. (1) The Trust shall cause to be kept proper accounts Accounts. and records in relation to all of its operations.

- (4) The Trust shall, as soon as practicable, but 20 within 4 months, after the end of the financial year to which a statement of accounts relates, transmit the statement to the Auditor-General for verification and certification.
- (5) The Auditor-General's certificate shall state that he has audited the accounts of the Trust relating to the 25 relevant financial year, and shall indicate whether the statement of accounts complies with subsection (3), and shall set forth any qualifications subject to which the certificate is given.

- (6) Nothing in this section prevents the alteration of the statement of accounts, with the approval of the Auditor-General, after its receipt by him and before its submission to the Minister.

SYDNEY CRICKET AND SPORTS GROUND BILL, 1977

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)
THE objects of this Bill are—

- (a) to constitute a corporation under the corporate name of the Sydney Cricket and Sports Ground Trust, which is to be subject to ministerial control (clause 5);
- (b) to provide that the Trust shall consist of 12 members, appointed by the Governor, 2 of whom shall be elected by the members of the Sydney Cricket Ground (clause 6);
- (c) to make provisions relating to the constitution and procedure of the Trust (clause 7 and Schedule 1);
- (d) to continue the dedication for the purposes of public recreation of the lands which constitute the Sydney Cricket Ground and Sydney Sports Ground (in this Note referred to as "the scheduled lands") and to make provision for the inclusion in those lands, and the dedication, of certain land (in Driver Avenue and Moore Park) adjacent to the scheduled lands (clauses 8 and 9);
 - (e) to provide that the dedication of the scheduled lands is not to be revoked except by an Act of Parliament (clause 10);
 - (f) to provide that the Trust shall be the sole trustee of the scheduled lands (clause 11);
- (g) to provide that the Trust shall, for certain purposes, be deemed to have an estate in fee simple in the scheduled lands and to make provision with respect to the alienating, charging, granting leases of, or licences with respect to, or the disposing in any way of, the scheduled lands (clause 12);
 - (h) to charge the Trust with the care, control and management of the scheduled lands (clause 13);
 - (i) to provide that the Trust may allow the scheduled lands or any part thereof to be used for certain specified purposes or for any other purpose approved by the Minister (clause 14);
 - (j) to enable the Trust, with the approval of the Minister, to acquire additional lands (in this Note referred to as "the additional lands"), to exchange, dispose of or otherwise deal with those lands, and to expend trust money in improving those lands and to provide that those lands may be used for the same purposes as the scheduled lands or for purposes connected with those purposes (clause 15);

- (k) to enable the Trust to carry out certain work in connection with the improvement, development and maintenance of the scheduled lands and the additional lands (in this Note referred to together as "the trust lands") and to enable the Minister, after a report has been made to him by the Trust, for the purpose of enabling any such work to be done, to terminate or vary or modify any agreement, lease or licence relating to the scheduled lands or any terms or conditions thereof (clause 16);
 - (1) to enable the Trust, with the approval of the Minister and the consent of the owner, to expend trust money in improving certain lands (clause 17);
 - (m) to enable the Trust for any of the purposes of the proposed Act to acquire by gift, bequest or devise any property and to carry out the conditions of the gift, bequest or devise (clause 18);
 - (n) to enable the Trust, with the approval of the Minister and the concurrence of the Treasurer, to indemnify a person with respect to any duty or tax payable in respect of or in connection with any such gift, bequest or devise (clause 19);
 - (o) to require the Trust to keep proper accounts and records in relation to its operations, to prepare and transmit annually to the Auditor-General for verification and certification a statement of accounts in a form approved by the Auditor-General, and to submit that statement together with the Auditor-General's certificate to the Minister and to require the Minister to lay that statement and that certificate before both Houses of Parliament (clause 20);
 - (p) to provide for the accounts of the Trust to be audited by the Auditor-General (clause 21);
 - (q) to authorise the Trust to invest money held by it in certain securities (clause 22);
 - (r) to empower the Trust to obtain advances by overdraft of current account in any bank and to enable the Treasurer to advance money to the Trust (clause 23);
 - (s) to empower the Trust, with the approval of the Minister and the concurrence of the Treasurer, to borrow money for certain purposes (clause 24);
 - (t) to require the Trust each year to prepare and forward to the Minister a report of its work and activities for the year and to require the Minister to lay the report before each House of Parliament (clause 25);
 - (u) to empower the Minister and any person authorised by him to enter and inspect the trust lands at any time (clause 26);
 - (v) to empower the Trust, or any officer of the Trust, to call in the aid of the police for the removal of any person found committing a breach of any by-law or causing annoyance or inconvenience to persons on, or going to or from, the trust lands (clause 27);

- (w) to provide for the appointment of a Secretary and other officers and employees of the Trust (clause 28);

- (a) indemnifying a person includes a reference to agreeing or undertaking to indemnify a person;
- 25 (b) a person includes a reference to his estate or his personal representatives;
 - (c) a duty or tax is a reference to a duty or tax under the law of the State or any other law; and

(d) a gift, bequest or devise to the Trust includes a reference to a proposed gift, bequest or devise to the Trust.

FINANCE.

- 20. (1) The Trust shall cause to be kept proper accounts Accounts. and records in relation to all of its operations.
- (2) The Trust shall, as soon as practicable, but within 6 months, after the end of each financial year of the 10 Trust, prepare and submit to the Minister for presentation to Parliament a statement of accounts, together with the Auditor-General's certificate given under this section in relation to the statement.

- (6) Nothing in this section prevents the alteration of the statement of accounts, with the approval of the Auditor-General, after its receipt by him and before its submission to the Minister.
- 5 (7) The Minister shall lay the statement of accounts, or cause it to be laid, together with the Auditor-General's certificate, before both Houses of Parliament as soon as practicable after the receipt by him of the statement.
- (8) The financial year of the Trust shall be the year 10 ending on the last day of February.

(4) The Auditor-General may dispense with all or 30 any part of the detailed inspection and audit of any accounts or records referred to in subsection (1).
