

TEACHING SERVICE (AMENDMENT) BILL, 1976

EXPLANATORY NOTE

THE objects of this Bill are-

- (a) to repeal section 24A of the Teaching Service Act, 1970—that section has the effect of overriding, in certain circumstances, the provisions of any law restricting the powers of the Director-General of Education to appoint persons with the appropriate qualifications to the Teaching Service, including the provisions of the "preference to unionists" clause included in the award applying to persons in the Teaching Service by the Industrial Commission of New South Wales pursuant to section 129B of the Industrial Arbitration Act, 1940; and
- (b) to repeal, by way of statute law revision, the Teaching Service (Amendment) Act, 1975, which inserted section 24a into the Teaching Service Act, 1970.
