WESTERN LANDS (AMENDMENT) BILL, 1978

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Crown Lands (Amendment) Bill, 1978.

The object of this Bill is to amend sections 36p and 36e of the Western Lands Act, 1901, as to be inserted by section 4 of, and Schedule 3 (3) to, the Western Lands (Amendment) Act, 1977.

Sections 36D and 36E relate to the payment of arrears by incoming holders following transfers of holdings and are to be amended by—

- (a) removing the requirement that the due dates for payment of deferred amounts be determined as if payment of the amounts had not been deferred; and
- (b) providing that a Minister's certificate as to the amounts due shall-
 - (i) include the due date for payment in respect of the last amount due instead of each amount due; and
 - (ii) protect only bona fide purchasers for value.
