## WILLS, PROBATE AND ADMINISTRATION (AMENDMENT) BILL, 1977

#### EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

THE objects of this Bill are-

- (a) to insert in the Wills, Probate and Administration Act, 1898, a new Part, IA, so as to enable a will to be admitted to probate if it conforms to the law of—
  - (i) the place where it was executed;
  - (ii) the place where, at the time of its execution or the testator's death, the testator was domiciled or habitually resided; or
  - (iii) a country of which, at the time of the execution of the will or the death of the testator, the testator was a citizen

(Schedule 1 (2));

- (b) to replace Division 2A of Part II of the Act with a new Division which prescribes new rules providing for the distribution of the estate of a person who dies wholly or partially intestate after the commencement of section 5 of the proposed Act and, in particular, providing that—
  - (i) where the deceased leaves a husband or wife and no issue, or a husband or wife and also leaves issue but the value of the estate (excluding any household chattels) does not exceed the prescribed amount (to be \$50,000 in the first instance), the surviving husband or wife will be entitled to the whole estate;
  - (ii) where the deceased leaves a husband or wife and also leaves issue and the value of the estate (excluding any household chattels) exceeds that prescribed amount, the surviving husband or wife will be entitled to the household chattels (if any), a statutory legacy of the prescribed amount (together with interest at the rate prescribed for the purposes of the proposed section 84A of the Act) and one-half of the estate (excluding any household chattels and the statutory legacy and interest) and the residue of the estate will be held in statutory trust for the issue;
  - (iii) where the deceased dies in the circumstances referred to in subparagraph (ii) and his estate includes an interest in a matrimonial home, the surviving husband or wife of the deceased will, by virtue of the proposed section 61p of the Act, have the right, subject to the provisions of the proposed Fourth Schedule to the Act, to require the administrator of the estate to hold that interest

in trust for him or her in full or, as the case may be, partial satisfaction of the statutory legacy and one-half share referred to in that subparagraph

(Schedule 2 (7));

- (c) to insert in the Act a new section, 84A, which will provide for a legacy or an annuity to carry interest at the prescribed rate, unless the contrary intention appears in the will or instrument pursuant to which the legacy or annuity is payable or the Supreme Court otherwise orders (Schedule 2 (8));
- (d) to amend section 92 of the Act so as to make it clear that claims in respect of the assets of the estate of a testator or intestate may be made on behalf of beneficiaries (including children conceived but not yet born at the death of the testator or intestate) as well as by creditors and others (Schedule 2 (9));
- (e) to insert in the Act a new section, 153, which will enable the Governor to make regulations for the purpose of the Act (Schedule 2 (10));
- (f) to insert in the Act a Fourth Schedule which prescribes the circumstances under which, and the conditions and restrictions subject to which, the surviving husband or wife of an intestate may exercise the right, to be conferred by the proposed \*section 61D of the Act, to acquire the intestate's interest in the matrimonial home (Schedule 2 (11)); and
- (g) to make other amendments of a minor, ancillary, consequential or revisionary nature.

The rules in the existing Division 2A of Part II of the Act whereby any money or property which an intestate has advanced to or settled on any of his issue is, subject to any contrary expressed intention, required to be taken as being in satisfaction or partial satisfaction of that issue's share of the intestate's estate are not included in the new Division 2A, but the present rules as to the distribution of the estate of an intestate who dies leaving neither a husband or wife nor issue are included in, and will continue to apply under, that new Division.

An Act to amend the Wills, Probate and Administration Act, 1898, with respect to the formal validity of wills, with respect to the distribution of intestate estates and with respect to certain other matters. [Assented to, 9th December, 1977.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Wills, Probate and Administration (Amendment) Act, 1977".

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Wills, Probate and Administration (Amendment) Act, 1977".

  - (a) firstly, in statutory trust for the brothers and sisters of the whole blood of the intestate; but if there are no such brothers or sisters, then

- (e) fifthly, in trust for the uncles and aunts of the intestate (being brothers or sisters of the half blood of a parent of the intestate) and, if more than one of them survive the intestate, in equal shares.
  - (7) In default of any person taking an interest under subsections (2) to (6), the estate shall belong to the Crown as bona vacantia, and in place of any right to escheat.
  - (8) The Crown, without prejudice to any other powers, may, out of the whole or any part of the property devolving on it as bona vacantia, provide for dependants, whether kindred or not, of the

- (c) the whole or a part of the matrimonial home was, at the time of the intestate's death, used as a hotel or lodging house; or
- (d) a part of the matrimonial home was, at that time, used for purposes other than residential purposes,

the right conferred by section 61D shall not be exercisable unless the Court, on the application of the administrator or of the surviving husband or wife of the intestate (not being the sole administrator), makes an order declaring itself to be satisfied that the exercise of that right is not likely to diminish the value of assets in the estate (disregarding household chattels, if any, and the interest of the intestate in the matrimonial home) or to make those assets more difficult to dispose of.

(3) During the period of 12 months referred to in subclause (1) (b) of this clause the administrator (not being the surviving husband or wife of the intestate) shall not, except as authorised under subclause (4) of this clause, without the written consent of the surviving husband or wife sell or otherwise dispose of the interest of the intestate in the matrimonial home except in the course of administration due to want of other assets.
