

**AUDIT (TRANSPORT AUTHORITIES) AMENDMENT  
BILL, 1980**

**EXPLANATORY NOTE**

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

This Bill is cognate with the Transport Authorities Bill, 1980.

The object of this Bill is to amend the Audit Act, 1902, consequent on the enactment of the proposed Transport Authorities Act, 1980.

The effect of the Bill is to remove certain transport accounts and operations from the application of section 59A of the Audit Act, 1902, which requires the Treasurer to transmit to the Auditor-General—

- (a) Income and Expenditure Accounts of certain transport services; and
- (b) a statement showing the net result of the operation of those services when combined with that of the Consolidated Revenue Fund, etc.

In this respect the accounts and operations of the State Rail Authority and the Urban Transit Authority will be treated in the same way as those of most other statutory authorities.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

5 **1.** This Act may be cited as the "Audit (Transport Authorities) Amendment Act, 1980". Short title.

**2.** (1) This section and section 1 shall commence on the date of assent to this Act. Commencement.

(2) Except as provided by subsection (1), this Act shall 10 commence on 1st July, 1980.

**Act No. 108, 1980.**

An Act to amend the Audit Act, 1902, consequent on the enactment of the Transport Authorities Act, 1980. [Assented to, 1st May, 1980.]

*Audit (Transport Authorities) Amendment.*

**BE** it enacted by the Queen’s Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

Short title.

**1.** This Act may be cited as the “Audit (Transport Authorities) Amendment Act, 1980”.

Commencement.

**2.** (1) This section and section 1 shall commence on the date of assent to this Act.

(2) Except as provided by subsection (1), this Act shall commence on 1st July, 1980.

**3.** The Audit Act, 1902, is amended—
