**EXPLANATORY NOTE**

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

The objects of this Bill are—

- (a) to increase, on and from 1st November, 1979, the maximum amount which may be yielded by the proceeds of a water rate levied by the Broken Hill Water Board ("the Board") from 10 per centum to 15 per centum on the assessed annual value of properties ratable under the Broken Hill Water and Sewerage Act, 1938 ("the Act") (clause 3); and
  - (b) to enable the fee payable in respect of a certificate as to the amount due and payable to the Board for rates or otherwise in respect of any land to be prescribed by the by-laws made under the Act (clause 4).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—
