

BUSH FIRES (AMENDMENT) BILL, 1980

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill is to amend the Bush Fires Act, 1949—

- (a) to alter the premium period in respect of which contributions to the New South Wales Bush Fire Fighting Fund ("the Fund") are payable by insurance companies from the year ending on 31st December to the year ending on 30th June (Schedule 1 (1) (a), (b), (e) and (f));
 - (b) to increase the penalty for a late return by insurance companies from \$20 to \$50 for each day of default and the penalty for a false return from \$500 to \$1,000 (Schedule 1 (1) (c) and (d));
 - (c) to permit the Minister to delegate his power to authorise the sale of equipment purchased from money in the Fund (Schedule 1 (2) (d));
 - (d) to require that any money recovered (whether under a policy of insurance, from the Bush Fire Fighters Compensation Fund under the Workers' Compensation Act, 1926, or otherwise) in respect of the damage to or loss of equipment purchased from money in the Fund be paid to the Fund (Schedule 1 (2) (e));
 - (e) to increase the membership of the Bush Fire Council of New South Wales from 25 to 27 members (Schedule 1 (3)); and
 - (f) by way of statute law revision and in other minor or ancillary respects.

Bush Fires (Amendment).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—
