BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

Short title. **1.** This Act may be cited as the "Capital Debt Charges (Transport Authorities) Amendment Act, 1980".

**Commence-
ment.** **2.** (1) This section and section 1 shall commence on the date of assent to this Act.

(2) Except as provided by subsection (1), this Act shall commence on 1st July, 1980.

**CAPITAL DEBT CHARGES (TRANSPORT AUTHORITIES)
AMENDMENT BILL, 1980**

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Transport Authorities Bill, 1980.

The object of this Bill is to amend the Capital Debt Charges Act, 1957, consequent on the enactment of the proposed Transport Authorities Act, 1980.

The Bill amends the Capital Debt Charges Act, 1957, by omitting references to certain authorities, which at present are required to be construed as references to the Public Transport Commission. Since Schedule 8 to the Transport Authorities Act, 1980, if enacted, would require such references to the Public Transport Commission to be construed as references to the State Rail Authority or the Urban Transit Authority, the amendment results in the exclusion of those new authorities from the operation of the Capital Debt Charges Act, 1957.
