Act No. 67, 1981.

An Act to amend the Church of England Trust Property Act, 1917, as a consequence of the inclusion of Norfolk Island in the Diocese of Sydney.
[Assented to, 28th May, 1981.]

Church of England Trust Property (Amendment).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Church of England Trust Property (Amendment) Act, 1981".

Commencement.

2. (1) This section and section 1 shall commence on the date of assent to this Act.

(2) Except as provided in subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Church of England (Norfolk Island) Act, 1981.

Amendment of Act No. 21, 1917.

3. The Church of England Trust Property Act, 1917, is amended in the manner set forth in Schedule 1.

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Church of England (Norfolk Island) Bill, 1981.

Norfolk Island now forms part of the Diocese of Sydney and the object of this Bill is to make a consequential amendment to the Church of England Trust Property Act, 1917.

Church of England Trust Property (Amendment).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—
