An Act to amend the Coal and Oil Shale Mine Workers (Superannuation) Act, 1941, with respect to the entitlement of widows to lump sum payments under that Act; and for other purposes. [Assented to, 1st May, 1980.]

Coal and Oil Shale Mine Workers (Superannuation) Amendment.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

Short title. **1.** This Act may be cited as the "Coal and Oil Shale Mine Workers (Superannuation) Amendment Act, 1980".

Commence- **2.** (1) Except as provided in subsection (2), this Act shall

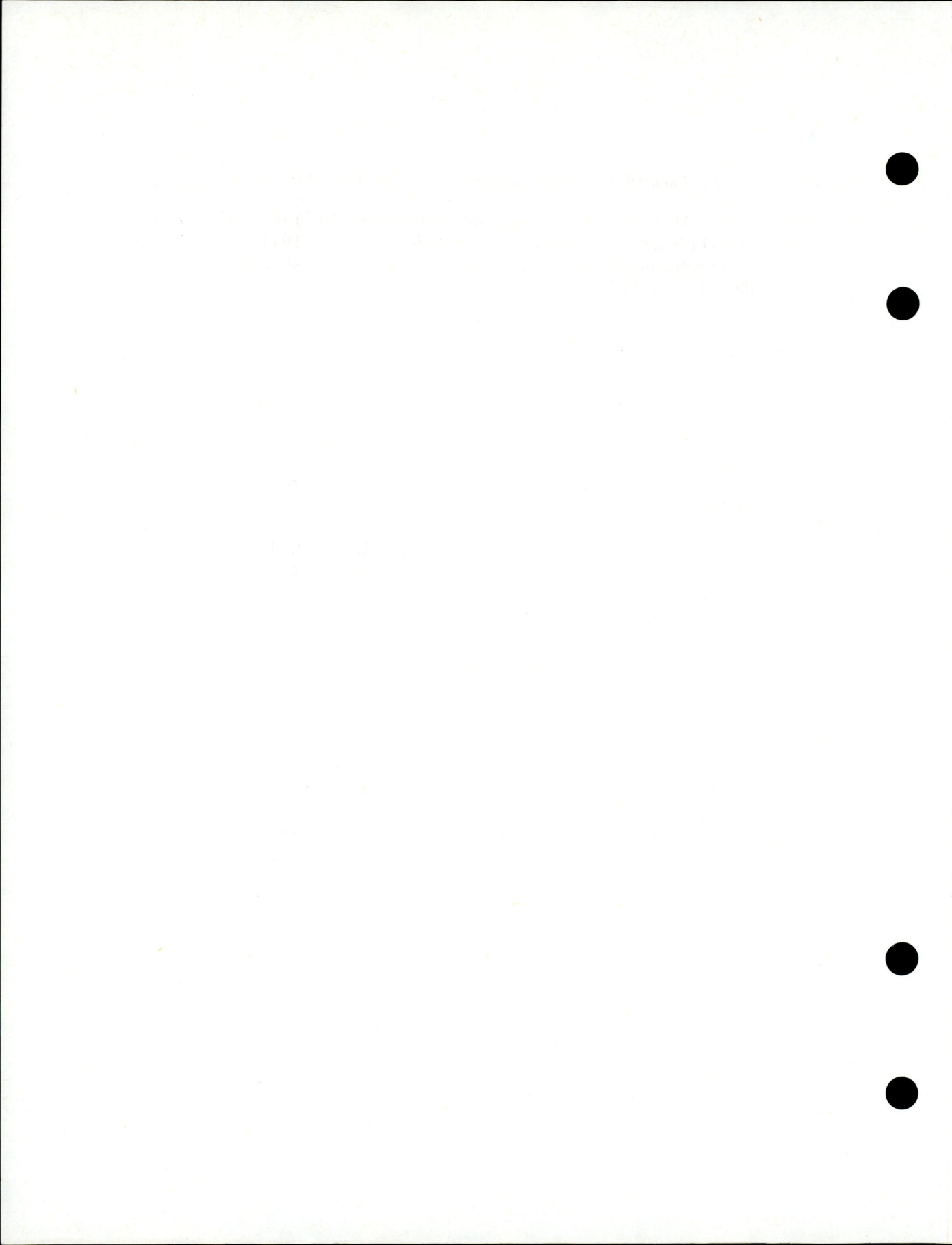

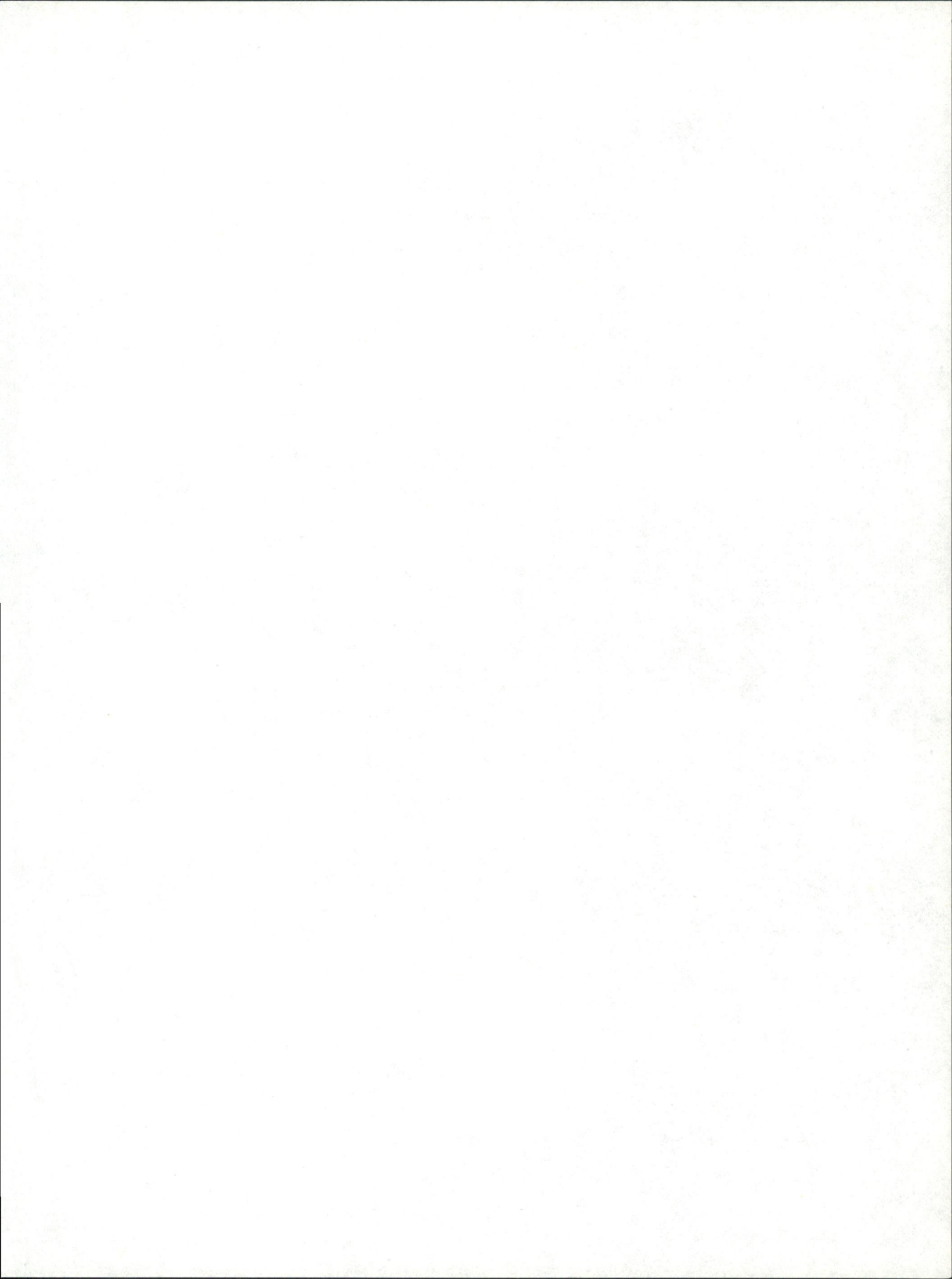
**COAL AND OIL SHALE MINE WORKERS (SUPERANNUATION)
AMENDMENT BILL, 1980**

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The objects of this Bill are to amend the Coal and Oil Shale Mine Workers (Superannuation) Act, 1941 ("the Principal Act"), so as—

- (a) to extend the powers of the Superannuation Tribunal constituted under the Principal Act to declare a period to be, with respect to a mine worker who has died, a period of engagement in work in the coal or oil shale mining industries (clause 3 (a));
 - (b) to extend until 30th January, 1981, the period during which certain amendments may be made to the Principal Act by regulations made pursuant to section 32 (5) of that Act and to provide that any such regulation, if it does not sooner cease to have effect, shall cease to have effect on 19th April, 1981 (clause 3 (b)); and
 - (c) to make other provisions of a minor or ancillary nature.
