
### **COMPANIES (CRIMES) AMENDMENT BILL, 1979**

#### EXPLANATORY NOTE

#### (This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Crimes (Amendment) Bill, 1979.

The object of this Bill is to include in section 381 of the Companies Act, 1961, provision to indicate that subsection (3) of that section (which provides that non-indictable offences are to be punished on summary conviction) is subject to the proposed section 475A (1) of the Crimes Act, 1900 (which provides that certain offences under the Companies Act, 1961, may be prosecuted in the Supreme Court in its summary jurisdiction).
