An Act to repeal the Coomealla Irrigation Area Deep Drainage Act, 1939; and for other purposes. [Assented to, 10th December, 1979.]

Coomealla Irrigation Area Deep Drainage (Repeal).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

Short title. **1.** This Act may be cited as the "Coomealla Irrigation Area Deep Drainage (Repeal) Act, 1979".

Commence- **2.** (1) This section and section 1 shall commence on the

(2) Except as provided in subsection (1), this Act shall commence on the day appointed and notified under section 2 (2) of the Water (Amendment) Act, 1979.

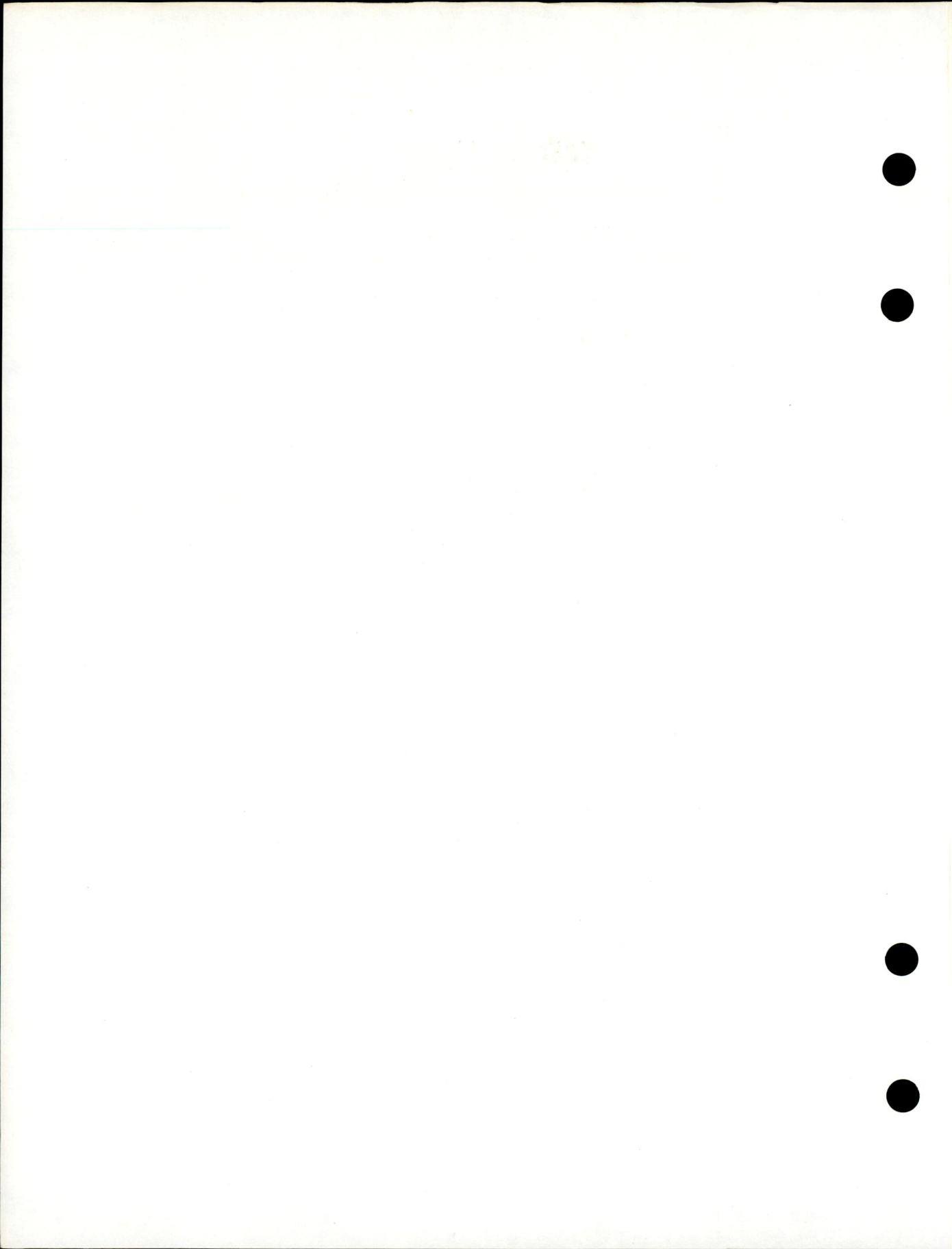
7. In respect of drainage works constructed, before the day referred to in section 2 (2), under the Coomealla Irrigation Area Deep Drainage Act, 1939, in the Coomealla Irrigation Area, the Water Resources Commission constituted under section 4 of the Water Resources Commission Act, 1976, may, by notification published in the Gazette, waive any rate, or the balance of any contribution, payable under Part II of the Irrigation (Amendment) Act, 1941, and outstanding immediately before that day, and the waiver has effect as if that rate or balance had been paid.

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The objects of this Bill are—

- (a) to repeal the Coomealla Irrigation Area Deep Drainage Act, 1939, (“the Principal Act”) (clause 3);
- (b) to amend the Public Works and Other Acts (Interest Rates) Amendment Act, 1976 (clause 4);
- (c) to deem drainage works constructed, before the day referred to in clause 2 (2), under the Principal Act to have been constructed under the Irrigation Act, 1912 (clause 5);
- (d) to apply the provisions of the Irrigation Act, 1912, to the drainage works constructed under the Principal Act (clause 6); and
- (e) to enable the Water Resources Commission to waive any rate, or the balance of any contribution, payable under Part II of the Irrigation (Amendment) Act, 1941, in respect of drainage works constructed, under the Principal Act, in the Coomealla Irrigation Area (clause 7).

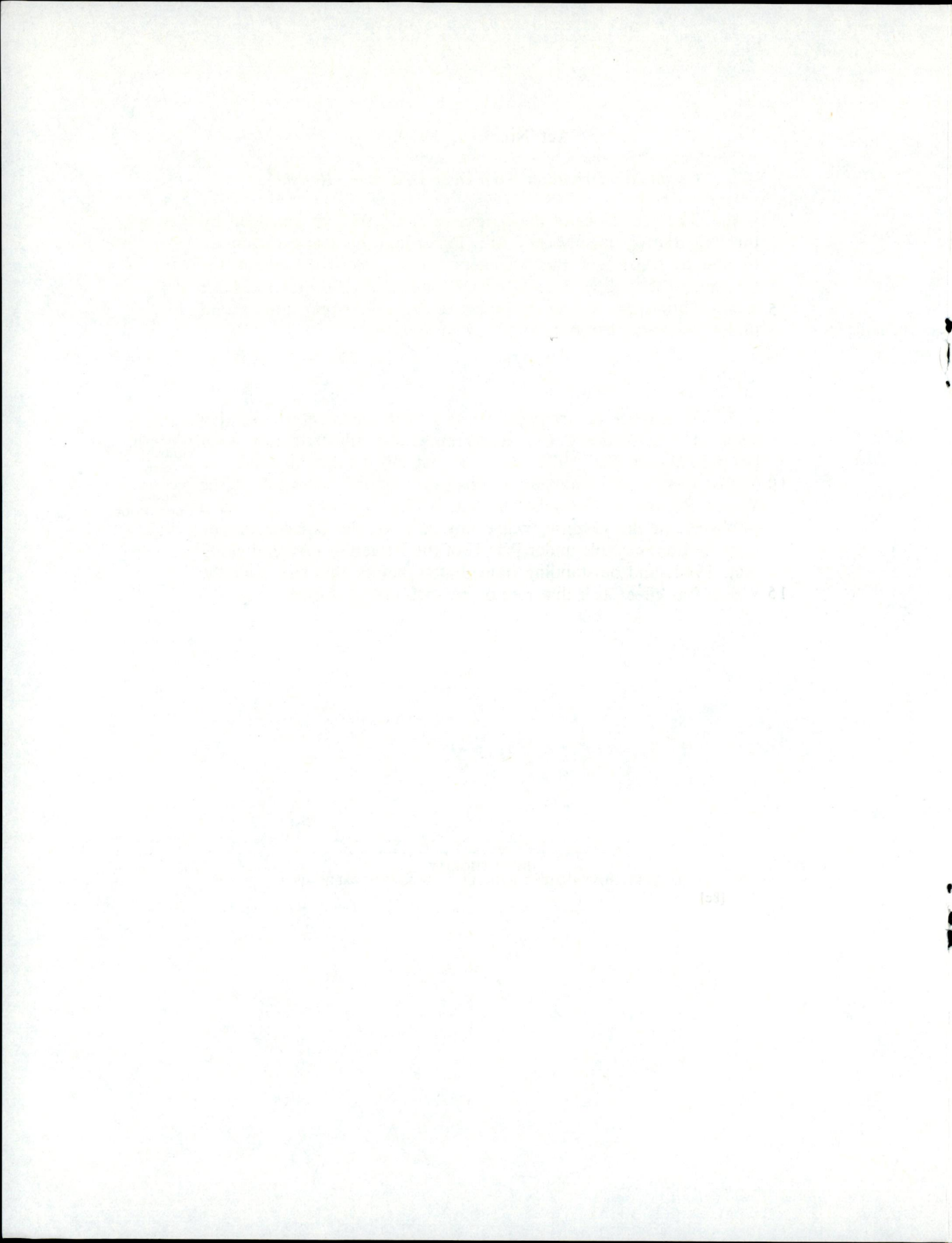
