EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Frustrated Contracts Bill, 1978.

The object of this Bill is to enable the Governor to make rules under the Courts of Petty Sessions (Civil Claims) Act, 1970, with respect to certain costs incurred in a court of petty sessions when an action under the Frustrated Contracts Act, 1978, is removed from such a court into the District Court.
