This Bill is cognate with the Crimes (Compensation) Amendment Bill, 1979.

The objects of this Bill are:-

- (a) to amend the Criminal Injuries Compensation Act, 1967 ("the Act"), so as to remove the responsibility for the approval of payments under the Act from the Treasurer to the Attorney General;
- (b) to enable the powers and duties under the Act of the Under Secretary of the Department of the Attorney General and of Justice, or the Acting Under Secretary of that Department, to be exercised or performed by any authorised Assistant Under Secretary of that Department;
- (c) to make amendments of the Act by way of statute law revision; and
- (d) to make other amendments of the Act of a minor or ancillary nature.
