BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

Short title.

1. This Act may be cited as the "Dairy Products (Repeal) Act, 1979".

Repeal of Act No. 17, 1933, Act No. 47, 1936, and Act No. 26, 1938. **2.** (1) The Dairy Products Act, 1933, is repealed. (2) The Dairy Products (Amendment) Act, 1936, is repealed.

(3) The Dairy Products (Amendment) Act, 1938, is repealed.

Amendment **3.** The Metric Conversion Act, 1978, is amended by omitting of Act No. 67, 1978. from Schedule 1 the matter relating to Act No. 17, 1933.

Validation. 4. The disposition by the New South Wales Dairy Products Board constituted under the Dairy Products Act, 1933, of its assets is validated.
