

GAMING AND BETTING (GREYHOUND RACING CONTROL BOARD) FURTHER AMENDMENT BILL, 1978

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

THE objects of this Bill are—

- (a) to enable the Greyhound Racing Control Board—
 - (i) to control and regulate the keeping of certain greyhounds;
 - (ii) to investigate and make reports to the Minister on matters relevant to the keeping of certain greyhounds; and
 - (iii) to grant or advance on loan money from the Greyhound Racing Control Board Fund for certain purposes relating to the welfare of greyhounds
 - (Schedule 1 (1));
 - (b) to enable the Greyhound Racing Control Board to make rules for or with respect to the control and regulation of the keeping of certain greyhounds (Schedule 1 (2));
 - (c) to enable the awarding of prizes, other than money, at a greyhound trial or training race (Schedule 1 (3)); and
 - (d) to make other provisions of a minor and consequential character.
