EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Plumbers, Gasfitters and Drainers Bill, 1979.

The objects of this Bill are-

- (a) to remove from the Gas and Electricity Act, 1935, the power of the Governor to make regulations for the licensing of persons to carry out gasfitting work; and
- (b) to prohibit the carrying out of certain gasfitting work except by persons who are the holders of licences or certificates of registration granted under the proposed Plumbers, Gasfitters and Drainers Act, 1979, in relation to that work or who do so under the immediate supervision of the holder of a licence of a class prescribed in relation to that work.


