BE it therefore enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Notwithstanding anything to the contrary contained or Stamp provided in or by the Stamp Duties Act, 1920, the stamp duty which shall be charged and payable in respect of any memorandum of transfer or other conveyance or instrument executed by the Trustees of the Hornsby War Memorial Committee pursuant to section 2 hereof shall be the sum of \$5,175 and no more.
