EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The objects of this Bill are-

- (a) to amend the Hunter Valley Conservation Trust Act, 1950 ("the Principal Act"), so as to increase the area in respect of which is required to be levied 25 per cent of the conservation rate levied in respect of the remainder of the Trust District described in that Act (clause 3 (b));
- (b) to provide that the concession referred to in paragraph (a) is to apply in respect of land described in Part 2 of the Schedule to the Principal Act at 1st January next following the making of the conservation rate to which the concession applies (clause 3 (a)); and
- (c) to make other provisions of a minor nature.

A BILL FOR

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

of that range southerly to its intersection with the generally western boundary of the said parish of Teralba, thence generally north-easterly by part of the boundary of the land described in Part 1 of this Schedule being the generally western boundary of that parish northerly to the north-western corner of portion 104 thence by the generally northern boundary of the said parish of Teralba generally easterly to its intersection with the southernmost western boundary of the parish of Hexham by that boundary of that parish northerly to the westernmost north-western corner of portion 12 by part of the westernmost southern boundary and part of the southernmost eastern boundary of portion 46 parish of Alnwick easterly and northerly to the south-western side of the New England Highway by that side of that highway south-easterly to the prolongation south-westerly of the southernmost south-eastern side of the road shown on plan catalogued R 3046-1603R by that prolongation north-easterly to the north-eastern side of the New England Highway by that side of that highway south-easterly to the western boundary of portion 59 REM parish of Alnwick thence by part of that boundary and part of the northern boundary of that portion northerly and easterly to the eastern boundary of portion 65 by part of that boundary northerly to the north-eastern side of the Main Northern Railway land by that side of that land south-easterly to the northern boundary of the said portion 59 REM by part of that boundary and its prolongation easterly to the left bank of the Hunter River by the said left bank of the Hunter River generally southerly to the south-eastern side of the Pacific Highway passing through portion 20 REM parish of Stockton county of Gloucester by a line southerly to the North Channel of the Hunter River by a line along that channel downwards to a point south of the southern extremity of Smiths Island thence northerly by a line to that southern extremity thence by the foreshores of Fullerton Cove and the left bank of the said North Channel of the Hunter River generally northerly generally easterly and generally southerly to the southern boundary of portion 8 and thence by that southern boundary of that portion easterly to the point of commencement.
