

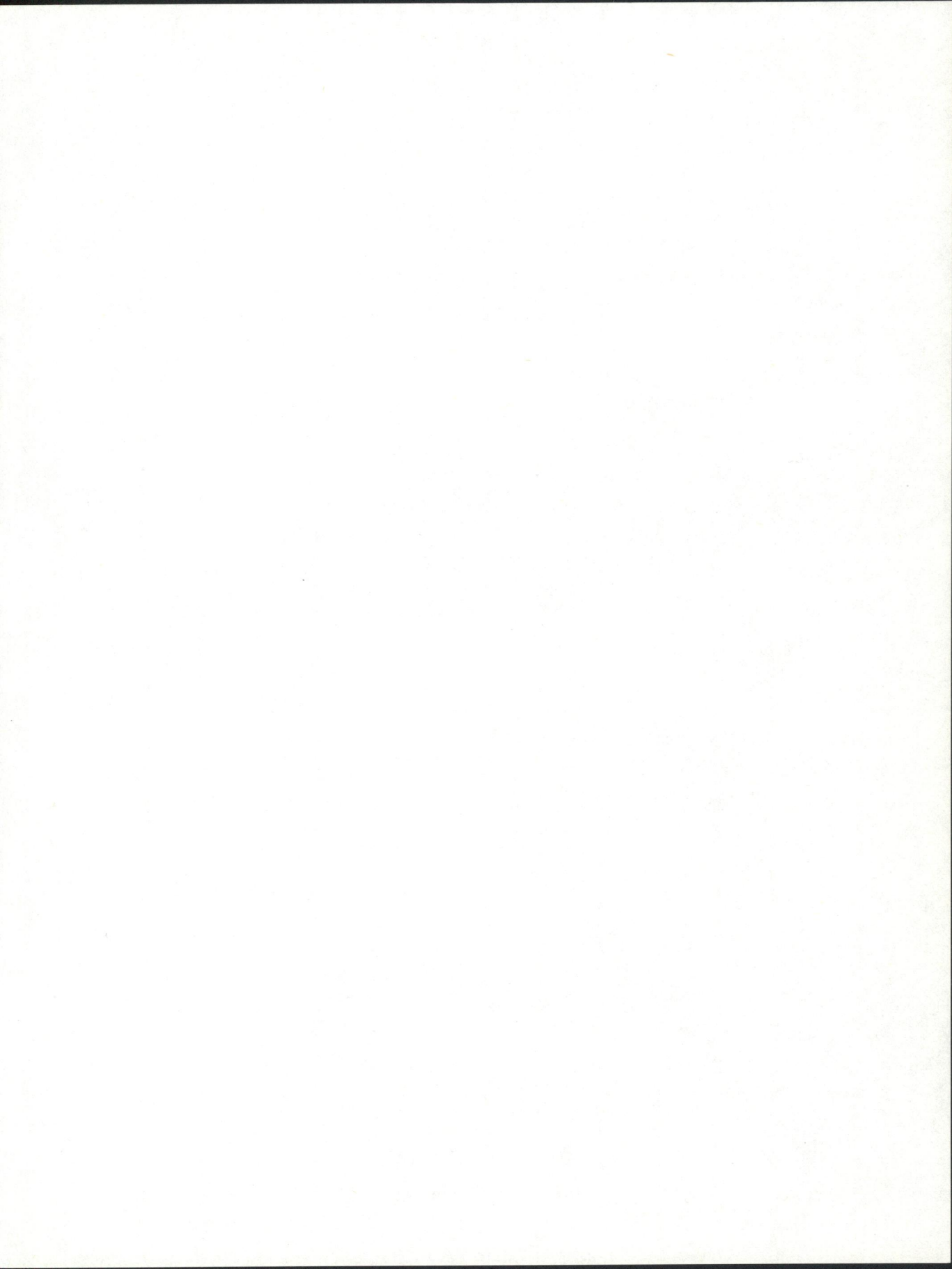
IRRIGATION (AMENDMENT) BILL, 1979

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The objects of this Bill are—

- (a) to amend the Irrigation Act, 1912 (“the Principal Act”), so as to apply the provisions of Part VI of the Water Act, 1912, as proposed to be amended by the Water (Amendment) Bill, 1979, to drainage works constructed under the Principal Act (clause 3—proposed section 24A);
- (b) to amend the Irrigation (Amendment) Act, 1941, and certain other Acts (clause 4 and Schedule 1);
- (c) to deem drainage works constructed, before the day referred to in clause 2 (2), under Part VIII of the Water Act, 1912, in the Coomealla Provisional Subsoil Drainage District to have been constructed under the Principal Act (clause 5); and
- (d) to enable the Water Resources Commission to waive any rate, or the balance of any contribution, payable under Part VIII of the Water Act, 1912, in respect of any drainage works constructed, under that Part, in the Coomealla Provisional Subsoil Drainage District (clause 6).

A BILL FOR

An Act to amend the Irrigation Act, 1912, consequent upon the enactment of the Water (Amendment) Act, 1979; and for other purposes.

Irrigation (Amendment).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

5 **1.** This Act may be cited as the "Irrigation (Amendment) Act, Short title. 1979".

2. (1) This section and section 1 shall commence on the date of assent to this Act. Commence-
ment.

 (2) Except as provided in subsection (1), this Act shall

20 **4.** Each Act specified in Column 1 of Schedule 1 is amended in the manner specified opposite that Act in Column 2 of Schedule 1. Amendment

Irrigation (Amendment).

5 **5.** Any drainage works constructed, before the day referred to in section 2 (2), under Part VIII of the Water Act, 1912, in the Coomealla Provisional Subsoil Drainage District shall be deemed to have been constructed under the Irrigation Act, 1912, as amended by this Act, as if the Irrigation Act, 1912, as so amended, had been in force at the time they were constructed.

10 **6.** In respect of drainage works constructed, before the day referred to in section 2 (2), under Part VIII of the Water Act, 1912, in the Coomealla Provisional Subsoil Drainage District, the Water Resources Commission constituted under section 4 of the Water Resources Commission Act, 1976, may, by notification published in the Gazette, waive any rate, or the balance of any contribution, payable under Part VIII of the Water Act, 1912, and outstanding immediately before that day, and the waiver has
15 effect as if that rate or balance had been paid.

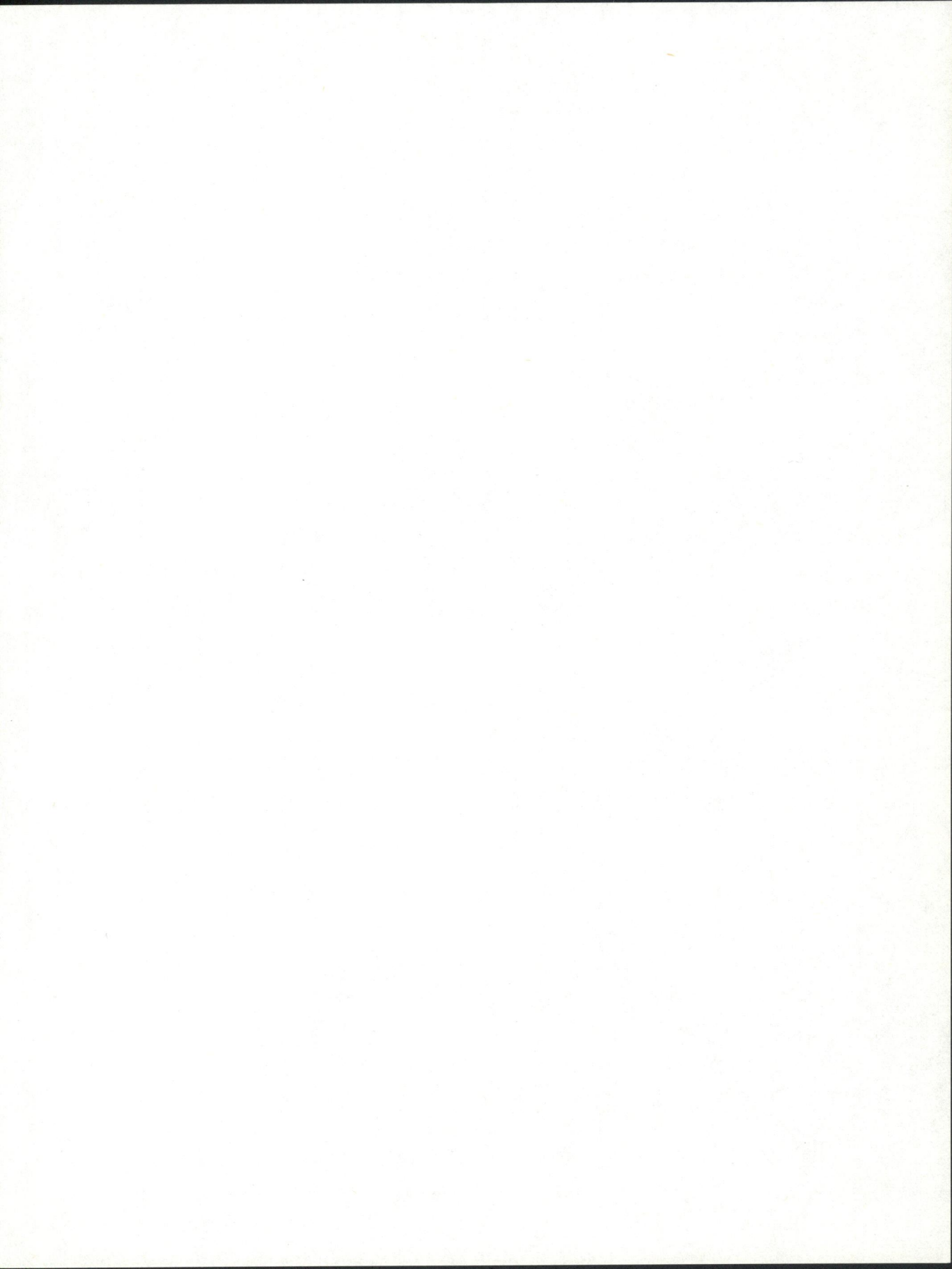
