
LIMITATION (POSSESSORY TITLES) AMENDMENT BILL, 1979

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Real Property (Possessory Titles) Amendment Bill, 1979.

The object of this Bill is to make such amendments to the Limitation Act, 1969, as are consequential upon the enactment of the Real Property (Possessory Titles) Amendment Act, 1979.

An Act to amend the Limitation Act, 1969, as a consequence of the enactment of the Real Property (Possessory Titles) Amendment Act, 1979.

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

- 5 1. This Act may be cited as the "Limitation (Possessory Short title. Titles) Amendment Act, 1979".
 - **2.** (1) Except as provided in subsection (2), this Act shall Commence-commence on the date of assent to this Act.
- (2) Section 3 shall commence on the day appointed and notified under section 2 (2) of the Real Property (Possessory Titles) Amendment Act, 1979.



Act No. 27, 1979.

An Act to amend the Limitation Act, 1969, as a consequence of the enactment of the Real Property (Possessory Titles) Amendment Act, 1979. [Assented to, 24th April, 1979.]

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Limitation (Possessory Titles) Amendment Act, 1979".

Commencement.

- 2. (1) Except as provided in subsection (2), this Act shall commence on the date of assent to this Act.
- (2) Section 3 shall commence on the day appointed and notified under section 2 (2) of the Real Property (Possessory Titles) Amendment Act, 1979.

3. The Limitation Act, 1969, is amended—

Sec. 8. (Saving of specified enactments.)

(a) by omitting from section 8 the matter "45" and by inserting instead the matter "45c";

Sec. 11. (Interpretation.)

(b) by inserting in the definition of "Mortgage" in section 11 (1) after the word "worth" the words "and also includes, in relation to land under the provisions of the Real Property Act, 1900, an encumbrance within the meaning of that Act";
