

**LOCAL GOVERNMENT (FORESTRY) AMENDMENT BILL,
1978 (No. 2)**

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Forestry (Amendment) Bill, 1978.

THE object of this Bill is to make a minor amendment to the second definition of "Lease" in section 4 of the Local Government Act, 1919, as a consequence of the amendments proposed to be made to the Forestry Act, 1916, by the Forestry (Amendment) Bill, 1978.

EXPLANATORY NOTE

This Bill amends the Local Government Act 1972 (No. 10) in relation to forestry.

The Bill contains the following provisions:

1. Section 100 of the Act is amended to provide that a local authority may, in relation to any land which is or has been used for forestry, do anything which it could do in relation to any other land.
