Lotto (Amendment).

BE it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

Short title.

1. This Act may be cited as the "Lotto (Amendment) Act, 1981".

Commencement.

2. (1) Except as provided in subsection (2), this Act shall commence on the date of assent to this Act.

(2) Section 5, in its application to Schedule 2, and Schedule 2 shall commence on such day as may be appointed by the Governor in respect thereof and as may be notified by proclamation published in the Gazette.

Principal Act.

3. The Lotto Act, 1979, is referred to in this Act as the Principal Act.

(2) The Minister may, by order published in the Gazette, declare to be a participating area for the purposes of this section any State or Territory of the Common-wealth in which it is lawful to conduct games of lotto under this Act.

(3) Out of any duty or additional duty received by him under section 15, the Minister may, in respect of a participating area, pay in accordance with subsection (4) one-half of—

- (a) so much of the duty as, in the opinion of the Minister, was paid to him in respect of subscriptions paid to any person in that participating area, being subscriptions to any game of lotto conducted under this Act; and
- (b) any additional duty that, in the opinion of the Minister, was paid to him and is attributable to the late payment of the portion of any duty referred to in paragraph (a).

(4) Any payment that may be made under subsection (3) in respect of a participating area shall be made to such person, on behalf of the State or Territory of the Commonwealth that is the participating area, as the Minister considers appropriate.

LOTTO (AMENDMENT) BILL, 1981

EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The State Lotteries (Amendment) Bill, 1981, is cognate with this Bill.

The objects of this Bill are-

- (a) to authorise the Minister under the Lotto Act, 1979 (the "Principal Act") to share equally with another State or a Territory of the Commonwealth, that is declared to be a participating area, duty on subscriptions to games of lotto conducted under that Act that are paid to persons in the other State or the Territory (Schedule 1);
- (b) to provide that the prize fund under the Principal Act shall be paid into a bank account, entitled the "Lotto Prize Fund Account", kept by the Minister as the corporation sole constituted as referred to in paragraph (c), instead of a bank account kept by the licensee, and to make provisions with respect to the administration of the account (Schedule 2 (2));
- (c) to constitute the Minister administering the Principal Act as a corporation sole for the purposes of his keeping and administering the Lotto Prize Fund Account and of exercising the investment powers to be conferred on him by section 14 of the Principal Act (Schedule 2 (3)); and
- (d) to make other provisions of a minor or ancillary character.


