EXPLANATORY NOTE

(This Explanatory Note relates to this Bill as introduced into Parliament)

The objects of this Bill are—

- (a) to constitute a corporation, to be called the Homebush Abattoir Corporation ("the Corporation"), to conduct on and from 1st January, 1979, in place of the Metropolitan Meat Industry Board, the operations now conducted by that Board (Schedules 1 (1)-(6) and 2);
- (b) to provide that the Corporation shall be managed by a General Manager (Schedule 1 (7));
- (c) to make provisions with respect to the appointment and offices of the General Manager, Acting General Manager and Deputy General Manager of the Corporation (Schedule 1 (11));
- (d) to continue in force amendments to the Cattle Slaughtering and Diseased Animals and Meat Act, 1902, and the Government Guarantees Act, 1934, effected by the Meat Industry Authority Act, 1970, notwithstanding its repeal by the Meat Industry Act, 1978 (Schedule 3);
- (e) to continue in force the by-laws made under the Meat Industry Act, 1978, until they are repealed or amended (Schedule 3); and
- (f) to make other amendments of a minor or ancillary nature.


