(This Explanatory Note relates to this Bill as introduced into Parliament)

The objects of this Bill are-

- (a) to extend the area of operations of The Metropolitan Water Sewerage and Drainage Board ("the Board") to the City of Blue Mountains with effect from 1st July, 1980 (clauses 2 (2) and 3);
- (b) to enable the Governor, by proclamation, to make provision for all matters necessary for or consequential upon that extension (clause 4):
- (c) to authorise the Board to levy rates in respect of land in the City of Blue Mountains for the year commencing 1st July, 1980, notwithstanding that at the time those rates are levied the City of Blue Mountains is not within the area of operations of the Board (clause 5);
- (d) to permit the council of the City of Blue Mountains to levy water and sewerage rates for the 6 months' period commencing on 1st January, 1980, instead of for the 12 months' period commencing on that date (clause 6 (1)); and
- (e) to reduce the maximum amount by which the rates referred to in paragraph (d) are reduced in respect of certain pensioners from \$60 to \$30 (clause 6 (2)).
