#### Motor Vehicles (Taxation) Amendment.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

#### Short title.

1. This Act may be cited as the "Motor Vehicles (Taxation) Amendment Act, 1981".

#### **Principal Act.**

2. The Motor Vehicles (Taxation) Act, 1980, is referred to in this Act as the Principal Act.

#### Adjustment of certain rates of tax in 1981.

3. (1) In subsection (2), the reference to the adjustment percentage for the year ending with 31st December, 1980, is a reference to the adjustment percentage for that year within the meaning of Part III of the Principal Act.

(2) The Principal Act applies in respect of the adjustment percentage for the year ending with 31st December, 1980, as if—

- (a) the references in sections 12 (1) and 13 of that Act to 1st July in the following year were references to 21st November, 1981; and
- (b) the reference in section 13 of that Act to 1st June in the following year were a reference to 21st October, 1981.
