**EXPLANATORY NOTE**

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

This Bill is cognate with the Valuation of Land (Amendment) Bill, 1978.

The object of this Bill is to require the Director of National Parks and Wildlife to forward copies of orders or proclamations relating to the declaration of protected archaeological areas, wildlife districts, wildlife refuges and game reserves to the Valuer-General.

10 (8) The Director shall forward a copy of a proclamation under this section to the Valuer-General as soon as practicable after the proclamation is published in the Gazette.

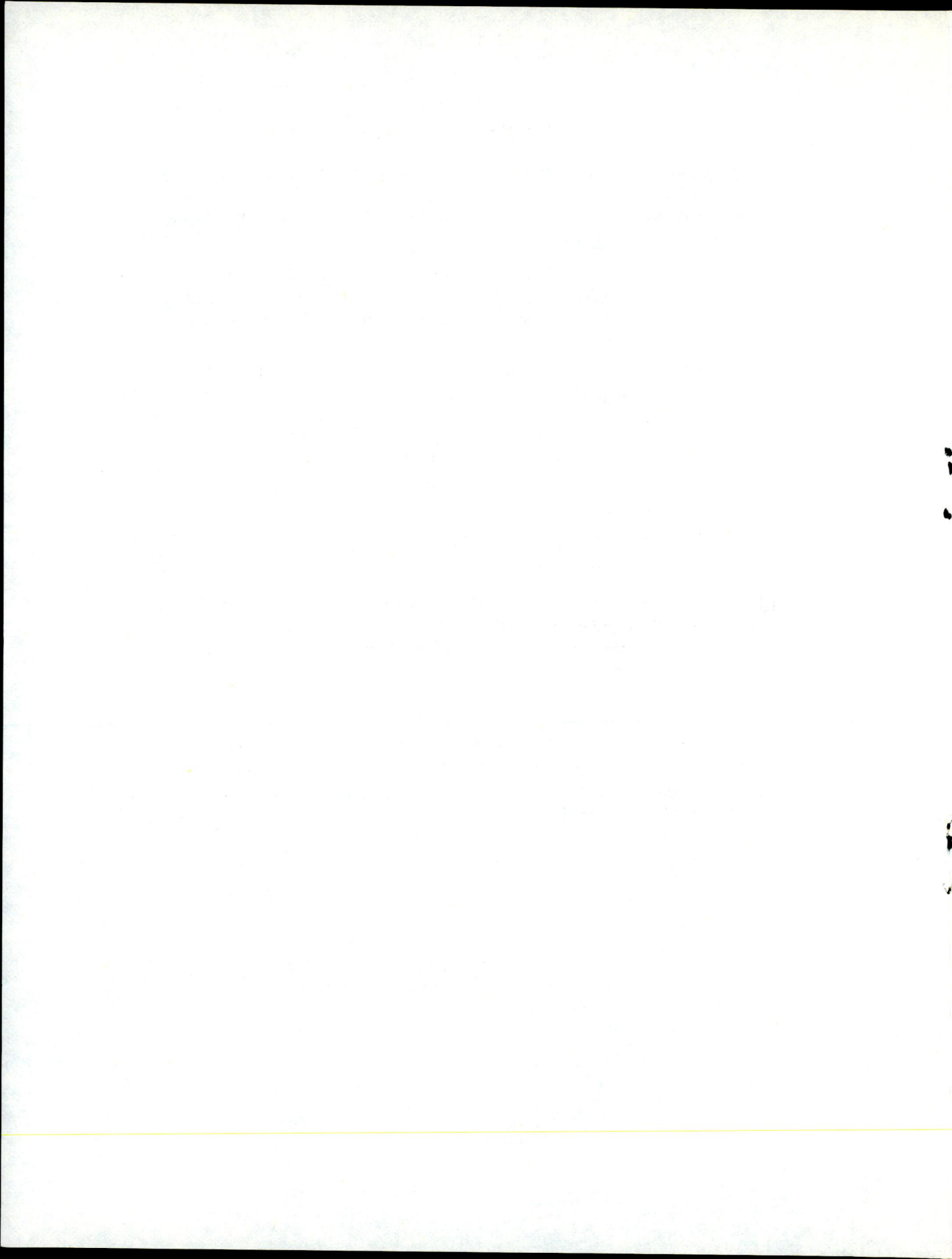

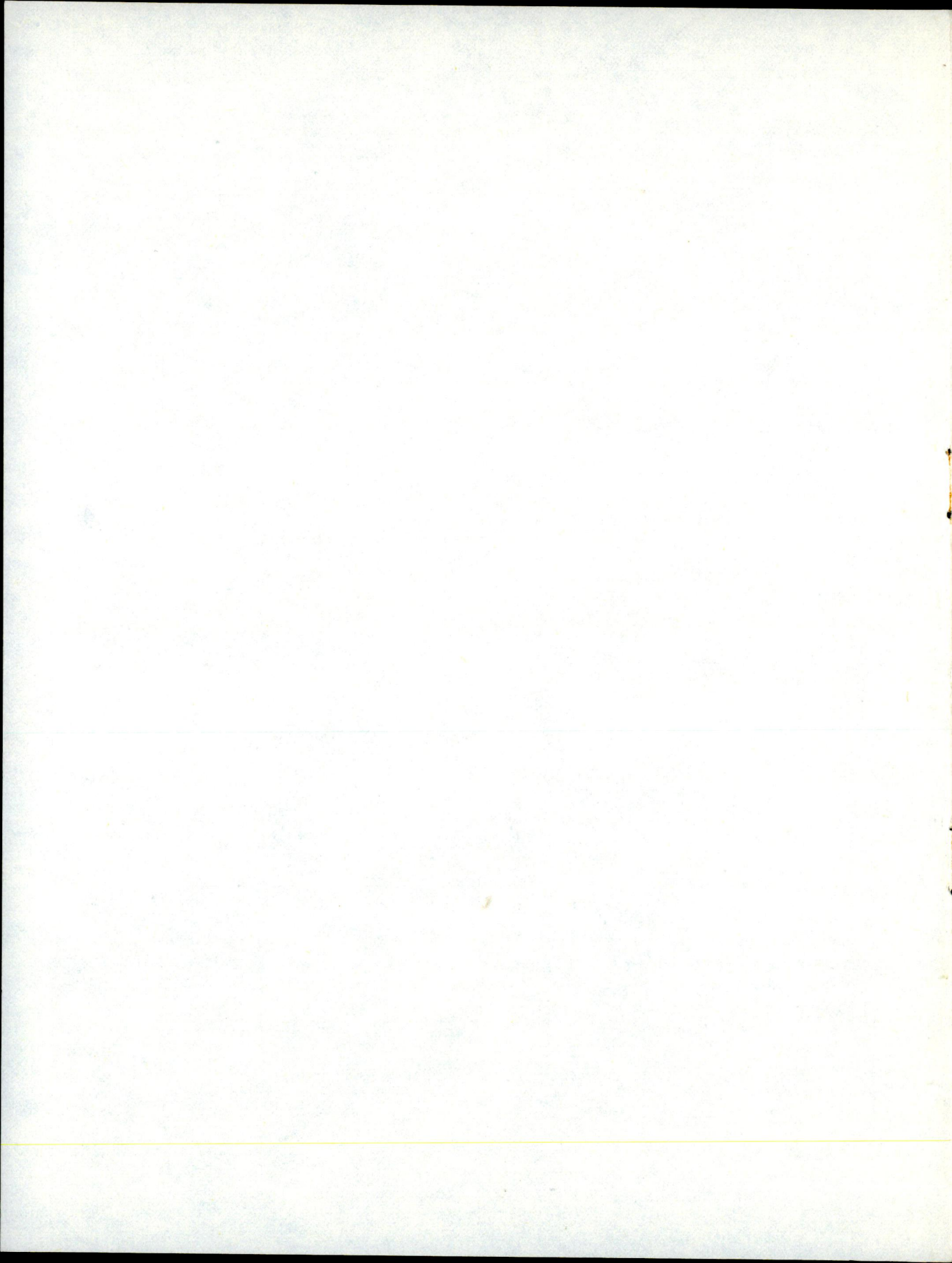

**An Act to amend the National Parks and Wildlife Act, 1974, to require the Director of National Parks and Wildlife to forward copies of certain orders and proclamations under that Act to the Valuer-General. [Assented to, 21st December, 1978.]**

*National Parks and Wildlife (Valuation of Land) Amendment.*

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

**1.** This Act may be cited as the "National Parks and Wildlife (Valuation of Land) Amendment Act, 1978".

Commence-

**2.** This Act shall commence on the day appointed and notified pursuant to section 2 (3) of the Valuation of Land (Amendment) Act, 1978.

**3.** The National Parks and Wildlife Act, 1974, is amended—

tation.)

(a) by inserting after the definition of "timber reserve" in section 5 (1) the following definition :—

"Valuer-General" means the valuer-general appointed under the Valuation of Land Act, 1916;

(b) by inserting after section 65 (2) the following subsection :—

(3) The Director shall forward to the Valuer-General—

(a) a copy of an order under subsection (1) as soon as practicable after the order is published in the Gazette; and

(b) notice of the revocation, pursuant to subsection (2) (c), of an order under subsection (1) as soon as practicable after the revocation is made.

- (c) by inserting after section 67 (5) the following subsection :— Sec. 67.  
(Wildlife districts.)

(6) The Director shall forward a copy of a proclamation under this section to the Valuer-General as soon as practicable after the proclamation is published in the Gazette.

- (d) by inserting after section 68 (7) the following subsection :— Sec. 68.  
(Wildlife refuges.)

(8) The Director shall forward a copy of a proclamation under this section to the Valuer-General as soon as practicable after the proclamation is published in the Gazette.

- (e) by inserting after section 69 (7) the following subsection :— Sec. 69.  
(Game reserves.)

(8) The Director shall forward a copy of a proclamation under this section to the Valuer-General as soon as practicable after the proclamation is published in the Gazette.

4. As soon as practicable after the date of assent to this Act, the Director shall forward to the Valuer-General a copy of each order under section 65 and each proclamation under section 67, 68 or 69 in force at that date. Transitional provision—existing orders and proclamations.
