

**PRICKLY-PEAR (DELEGATIONS) AMENDMENT BILL, 1981**

**EXPLANATORY NOTE**

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

This Bill is cognate with the Crown Lands (Miscellaneous Provisions) Amendment Bill, 1981.

The object of this Bill is—

- (a) to amend section 7A of the Prickly-pear Act, 1924, so as to remove the requirement to prescribe—
  - (i) the holders of the offices to whom the Minister may delegate his powers, authorities, duties and functions under that Act; and
  - (ii) the powers, authorities, duties and functions of the Minister that may be delegated under that Act; and
- (b) to make other amendments to that section of a minor, consequential or ancillary nature.

*Prickly-pear (Delegations) Amendment.*

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

**5 Short title.**

1. This Act may be cited as the "Prickly-pear (Delegations) Amendment Act, 1981".

**Principal Act.**

2. The Prickly-pear Act, 1924, is referred to in this Act as  
10 the Principal Act.

**Amendment of Act No. 31, 1924.**

3. The Principal Act is amended in the manner set forth in Schedule 1.

**Savings.**

15 4. A delegation—

- (a) made under section 7A of the Principal Act; and
- (b) in force immediately before the date of assent to this Act,

shall be deemed to be a delegation made under section 7A of the  
20 Principal Act as in force after the date of assent to this Act.
