

# PUBLIC WORKS (AMENDMENT) BILL, 1978

### EXPLANATORY NOTE

# (This Explanatory Note relates to this Bill as introduced into Parliament)

The object of this Bill (Schedule 1) is to amend section 34 of the Public Works Act, 1912, to increase from \$400,000 to \$1,000,000 the estimated cost of public works which may be carried out without following the procedure prescribed by that section.

As a consequence, certain other references in section 34 of that Act to the amount of 400,000 are to be altered to 1,000,000. The effect of these alterations will be:—

- (a) to provide that the Governor may direct that any public work may be carried out under the Act where the estimated cost does not exceed \$1,000,000; and
- (b) to provide that the Governor, notwithstanding that the cost of the work exceeds \$1,000,000, may direct that works of water supply, sewerage or drainage, public schools, hospitals, public offices and certain other similar works may be carried out under the Act.

An amendment to section 24 of the Act is also being made to bring it into line with section 34 as it is proposed to be amended.

Schedule 2 to the Bill makes certain amendments to the Act for the purpose of statute law revision.
