
## STATUTORY AND OTHER OFFICES REMUNERATION (ENERGY AUTHORITY) AMENDMENT BILL, 1979

#### EXPLANATORY NOTE

#### (This Explanatory Note relates to this Bill as introduced into Parliament)

This Bill is cognate with the Energy Authority (Amendment) Bill, 1979.

The object of this Bill is to remove from the Schedule of Public Offices in the Statutory and Other Offices Remuneration Act, 1975, the office of Chairman of The Electricity Authority of New South Wales and to include in that Schedule the office of Chairman and General Manager of the Energy Authority of New South Wales.

**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—
