Short title.

1. This Act may be cited as the "Statutory and Other Offices Remuneration (Fish Marketing Authority) Amendment Act, 1979".

- (2) Except as provided in subsection (1), this Act shall commence on the day on which Schedule 5 (1) to the Fisheries and Oyster Farms (Amendment) Act, 1979, commences.

3. The Statutory and Other Offices Remuneration Act, 1975, is amended by omitting from Part 1 of Schedule 2 the words Schedule 2. "Chairman of The New South Wales Fish Authority.".
