**BE** it enacted by the Queen's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

Short title.     **1.** This Act may be cited as the "Statutory and Other Offices Remuneration (Government Insurance) Amendment Act, 1978".

**EXPLANATORY NOTE**

**(This Explanatory Note relates to this Bill as introduced into Parliament)**

This Bill is cognate with the Government Insurance (Amendment) Bill, 1978.

The object of this Bill is to amend the Statutory and Other Offices Remuneration Act, 1975, to provide for the remuneration of the Chairman and other full-time members of the proposed Government Insurance Office of New South Wales Board and to delete provisions relating to the remuneration of the General Manager of the Government Insurance Office of New South Wales.
